SUBJECT: Update and request for next steps regarding the Implementation Phase of the Aging at Home Project

PURPOSE

- To update the Local Trust Committee (LTC) on the status of the Implementation Phase of the Aging at Home Project;
- To provide the Lasqueti Advisory Planning Commission (APC) minutes and recommendations for review and consideration by the Local Trust Committee; and
- To request further direction from the LTC to staff regarding the APC recommendations and next steps for staff in this phase of the project

UPDATE

At the LTC regular business meeting on February 20, 2017, the LTC passed the following resolution:

LA-LTC-2017-004

That the Lasqueti Island Local Trust Committee request staff to refer to the Advisory Planning Commission for community input regarding Recommendations #6, #7, #9, and #11 of the Aging at Home on Lasqueti Island Final Report (November 2016).

Staff sent a referral package to the Lasqueti APC, who met on March 21, 2017 to discuss Recommendations #6, #7, #9, and #11 of the Aging at Home on Lasqueti Island Final Report (November 2016); and the draft minutes from that APC meeting are attached (see attachment 1).

Staff are requesting the LTC to review the APC's draft meeting minutes, and to provide further direction and next steps to staff with respect to the APC's recommendations, including their recommendations that the LTC not proceed with Recommendations #6, #7, #9, and #11 of the Aging at Home on Lasqueti Island Final Report (attachment 2).

The LTC also passed the following resolution at the February 20, 2017 LTC meeting:

LA-LTC-2017-003

that the Lasqueti Island Local Trust Committee direct staff to review and draft amendments to the Official Community Plan as recommended in the Aging at Home on Lasqueti Island Final Report (November 2016), including:

- a. Objectives 7 and 8 to Section 3.1 Residential Land Use;
- b. Policies 11, 12, 13, 14, and 15 to Section 3.1 Residential Land Use; and
- c. Incorporating the objective to "support community initiatives to advance home support through a made in Lasqueti style home support service."

Due to time and resource constraints, staff was unable to follow up with the above direction for this LTC meeting. In advance of the June 26 LTC meeting, staff will review and draft amendments to the OCP as directed above, as well as follow up with any further direction assigned by the LTC in consideration of the APC's recommendations.

NEXT STEPS

Staff are requesting clear direction from the LTC regarding how they would like to move forward with the Aging at Home Project at this time.
