Location of vessel</li> <li>b. Vessel – Multiple angles including the entire vessel as well as relevant close-ups.</li> <li>c. Close-up of contaminants (if present)</li> <li>d. Close-up of vessel name and identification number (if present)</li> </ol>	<ol style="list-style-type: none"> <li>2. Please make sure that unless specifically known that the values for size and location are estimated.</li> <li>3. Describe the location of the vessel in as much detail as possible if the vessel is in a location that may be difficult to find again.</li> <li>4. Information on the vessel is essential for the identification of the owner but do NOT attempt to enter an abandoned or derelict vessel, unless you have followed all safety protocols.</li> </ol>
