**Re: Letter of Support for Galiano Conservancy Association's "Mid-Island Protected Areas Network Expansion & Habitat Enhancement Project"**

On behalf of Islands Trust Council, I wish to extend our support to the Galiano Conservancy Association's "Mid-Island Protected Areas Network Expansion & Habitat Enhancement Project". The Mid-Island Protected Area Network (MIPAN) is a 320 ha contiguous network of conservation lands that span mid-Galiano Island, from the Strait of Georgia to the Trincomali Channel, and within the treaty and territorial area of Penelakut First Nation and Coast Salish Peoples. The goal of this project is to expand the MIPAN by securing the 46.77 ha Quadra Hill property, as well as to perform restoration treatments and enhanced forest management on disturbed ecosystems. The project outcomes include improved wetland and forest habitat, increased carbon storage and heightened ecosystem connectivity on Galiano Island, which is located in the Islands Trust Area.

Islands Trust is a special purpose government mandated to preserve and protect over 450 islands in the Salish Sea. The Islands Trust Area is located in Coast Salish Territory, within the treaty lands and territories of a number of First Nations. These lands and waters have been the homelands of Indigenous Peoples since time immemorial. Islands Trust recognizes the vital role we must all play in preserving and protecting the incredibly rich Indigenous cultural and spiritual heritage of the region. In 1974, the Government of British Columbia enacted the Islands Trust Act in recognition of the unique needs of these biodiverse and ecologically sensitive islands and their vulnerability to development pressures from neighbouring urban centres. Located within the Coastal Douglas-fir and Coastal Western Hemlock biogeoclimatic zones, the Trust Area is home to an exceptionally high biodiversity of rare and culturally significant species, including over 100 federally-listed and over 300 provincially-listed species at risk.

The Islands Trust Conservancy holds title to a neighbouring 40.5 ha property, the Vanilla Leaf Nature Reserve, that was purchased with help from the Galiano Conservancy in 2013 to create a contiguous corridor of conservation land across Galiano Island. However, the existing corridor is only 160 m wide at its narrowest point. Protecting the Quadra Hill property will remove this bottleneck and expand the protected corridor to over a kilometre wide across much of the island, greatly improving ecosystem connectivity. Much of the Quadra Hill property is part of the same watershed that drains through the adjacent Vanilla Leaf and Great Beaver Swamp Nature Reserves. Any logging or development on the Quadra Hill property has the

potential to negatively impact these existing protected areas. Should Quadra Hill not be protected, and logging activity commences as allowed under current property zoning, ecosystems in neighbouring protected areas are likely to be degraded by runoff, erosion, and fragmentation.

This project is important not only because it will protect and restore the threatened ecosystems found on the Quadra Hill property, ensuring that they continue to store and sequester carbon, but also because of Quadra Hill's strategic location within the MIPAN. Protecting Quadra Hill will help insulate neighbouring protected areas from the spillover impacts of logging.

This project has the potential to have a very positive impact on forests and wetlands across the Mid-Island Protected Area Network of Galiano, helping to ensure these ecosystems continue to act as carbon sinks. The proposed project also supports Islands Trust's goals of establishing networks of protected areas that serve to preserve, protect, and restore local carbon sinks, biodiversity hotspots, species migration corridors, and contiguous forest habitat across the Islands Trust Area.

Islands Trust Council strongly supports the Galiano Conservancy Association's project proposal and urges you to fully fund this project. We look forward to future collaboration with the Galiano Conservancy Association on this and other initiatives that support **habitat conservation and** climate resilience in the Islands Trust Area.
