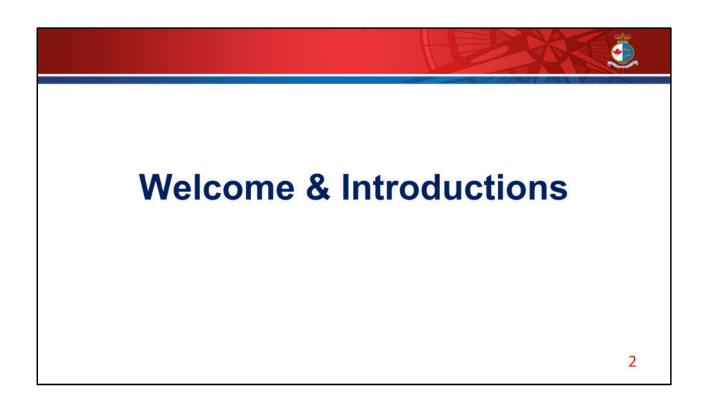

CCG Mandate & Authority



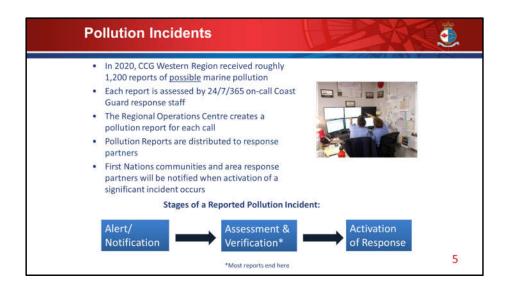
Under the *Oceans Act* and the *Canada Shipping Act 2001*, Coast Guard's mandate is to ensure an appropriate response to *all* ship-source and mystery-source (unknown origin) marine pollution spills in Canadian waters.

- CCG is the lead federal agency responsible for ensuring an appropriate response to marine pollution incidents.
- CCG exercises a leadership role in responses to:
 - ship-source spills,
 - · mystery-source spills,
 - pollution incidents that occur at oil handling facilities as a result of loading or unloading oil to or from ships.
 - spills from any source originating in foreign waters that impact Canadian waters.



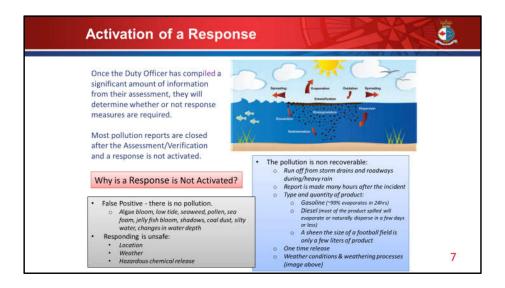

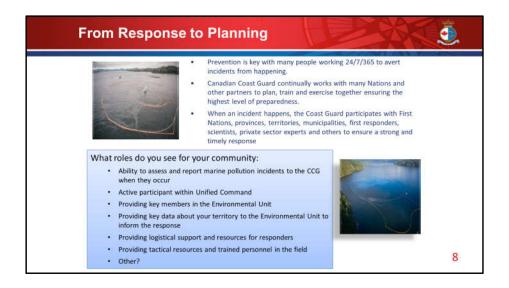


• Assessment time varies: depends on many factors such as time of day, location, weather, assets available





- Sometimes no response is the best response: weathering, fuel types etc.
- Weathering: The "weathering" process refers to the changes that occur to oil as it spends time in the environment. After oil is released, it undergoes a wide variety of physical, chemical, and biological processes that begin to transform the oil almost immediately.
 - · Early stages of spill: evaporation, spreading, dispersion, dissolution
 - · Mid stages: emulsification
 - Later states: Oxidation, sedimentation and sinking, biodegradation
- Some fuels will be gone from the water in a short period of time, Gasoline for example 99% evaporates in 24 hrs, gasoline can't be contained as it becomes a safety hazard
- · This information leads into what will be discussed in the intro course mentioned earlier

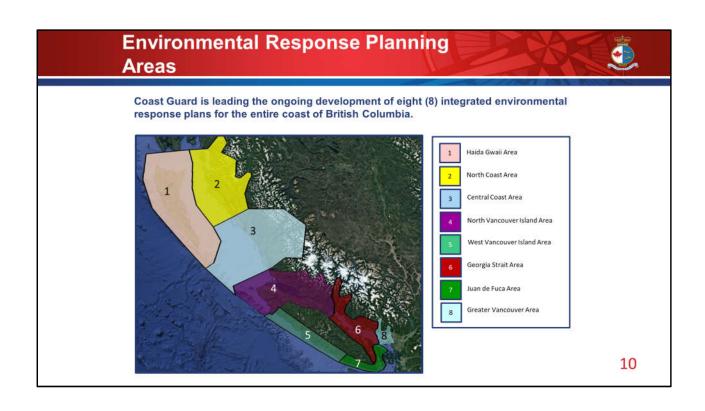

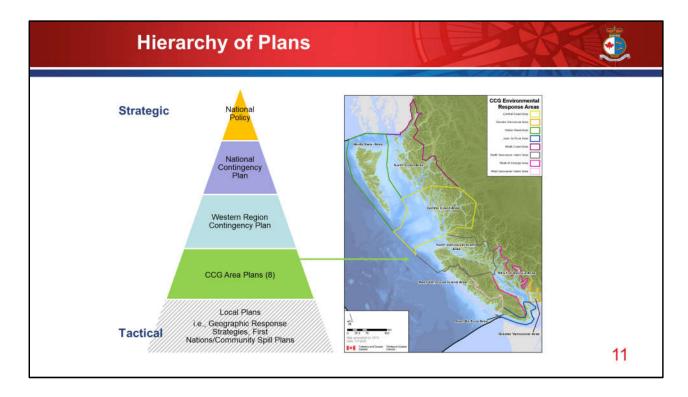

- The goal of Integrated Environmental Response plans, developed in collaboration with all spill response partners, is to improve our ability to prepare for, and respond to ship-source and mystery-source pollution incidents in Canadian waters.
- · The development of these plans focuses on:
 - o building relationships and partnerships;
 - connecting roles and responsibilities of all spill response partners within an identified area;
 - building understanding of Incident Command System and preparing for its implementation during spill response, including Unified Command;
 - o clarifying alerting and notification procedures;
 - o documenting logistics and other geographically specific information; and
 - incorporating unique local risks and features and how these will impact environmental response

National policies set by Transport Canada, provide the guidelines and regulatory structure for the preparedness and response to marine oil spills.

Coast Guard implements these policies in its Marine Spill Contingency Plans – National and Western Region Chapters and Area Response Plans.

Local plans are more tactical and could include Geographic Response Strategies

This graphic shows an overview of a hierarchy of dedicated spill response plans put in place for spill preparedness and response:

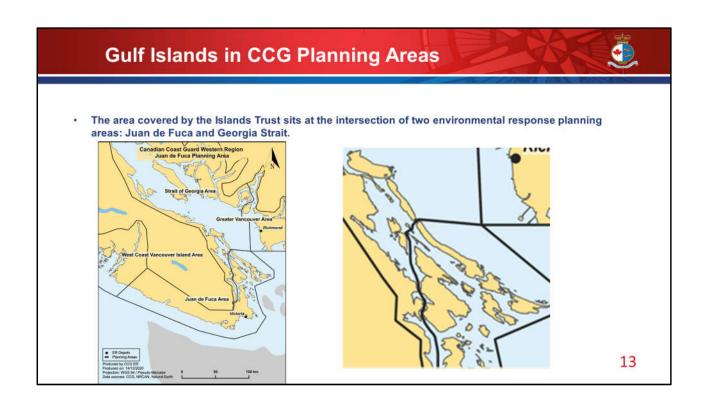
- At its highest levels, there are the national policies set for spill preparedness and response.
- Further down, these policies are implemented in regional, area, and local plans that are tailored to the unique
 needs of their environments and the organizations participating within that area -- all aimed to ensure a
 coordinated, effective response.
- The PIER project aims to further develop the Government of Canada's ability to co-create specially tailored plans
 that integrate spill response, Training and Exercises to continually develop our collective preparedness and
 response capacity and capabilities in a sustainable way.

Coast Guard Area Response Plans



- Area Response Plans align with the framework outlined in the Marine Spill Contingency Plan – Western Region Chapter and are approved and signed by the CCG Assistant Commissioner, Western Region. 2021 Plans are currently being signed off by the Assistant Commissioner and will be made public in the coming weeks.
- Plans include information on alerting and notification procedures and identify steps for activating a coordinated response. Appendices and Annexes include area specific content.
- · Plan development activities include:
 - establishing working group(s) with a focus on introducing Environmental Response, response planning under the current regime, and
 - conducting workshops on specific topics to facilitate an increased common understanding of ICS/spill response and to support the planning process.
- Coast Guard Area Response Plans are intended to be "evergreen" and will be regularly updated as these plans mature.

Facilities

The facilities unit is responsible for the setup, maintenance and demobilization of incident facilities, such as staging areas or the incident command post. This unit also provides sleeping and sanitation facilities for incident personnel. This section outlines some considerations for establishing these types of facilities in the West Coast Vancouver Island area, as well as provides some pre-identified sites that may be used. For large incidents in the West Coast Vancouver Island area an incident command post would likely be stood up in a location that has sufficient accommodation, medical and food services as to not be an issue. Depending on the exact location of the incident, field crews may require to have food go with them to the response site, but they are likely able to travel at the end of the day to return to their lodging.

Incident Command Posts

The following criteria should be considered when identifying Incident Command Posts:

ICP Identifier (Name, location)

Access (parking, etc)

Maximum capacity

Internal amenities (meeting spaces, breakout rooms, washrooms, kitchen)

Virtual Incident Command Post

The Coast Guard has successfully tested the ability to carry out multi-day coordination activities required for a large scale response while in a virtual environment. In the event a virtual ICP is established, the primary platform of choice will be Microsoft Teams and any other platform accessible to the ICP participants both internally and externally to CCG.

Accommodations

The plan area includes both easily accessible and remote locations. In places with high tourism such as Tofino, Ucluelet, and Port Alberni, available accommodations may be affected by seasonality. In remote areas such as Gold River, Tahsis and Bamfield, temporary accommodations such as camp barges, fishing lodges, or other rapidly deployable lodgings should be considered. In the event of reduced accommodation availability in smaller communities with no temporary accommodation options, the closest municipal hub of Campbell River could be considered.

Ground Support

The ground support unit is responsible for the management of tactical equipment,

vehicles, mobile ground support equipment and fueling services; transportation of personnel, supplies, food and equipment in support of incident operations. The Vessel Support Unit is responsible for coordinating transportation on the water and between shore resources, as well as fueling, docking and maintenance requirements. This section outlines available methods of transportation in the plan area. The Canadian Coast Guard's Integrated Technical Services (ITS) directorate has a variety of experts that may provide these services during a response.

A digital library with manuals for maintenance and use of response equipment is kept by the CCG's Marine Civil Infrastructure program.

Travel in and around some parts of the WCVI area may pose some limitations to a response. Highway, airport, and marine services and infrastructure may be limited for some locations within the planning area.

Personnel/Equipment Mobilization

Responders may find barriers when mobilizing personnel and equipment in the West Coast Vancouver Island area. There are some remote areas that may be only accessed by vessel. The following table provides approximate times for responders to reach different areas in the Plan Area. Note that these times are assumed that responders are on site and that weather conditions permit suitable travel conditions. Unless stated otherwise, these travel times are for a truck and trailer.

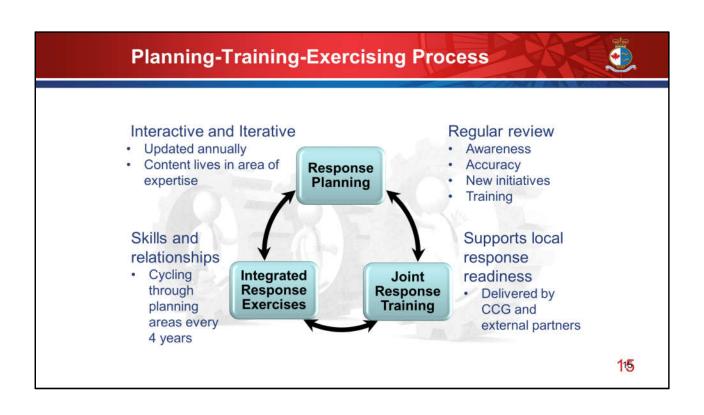

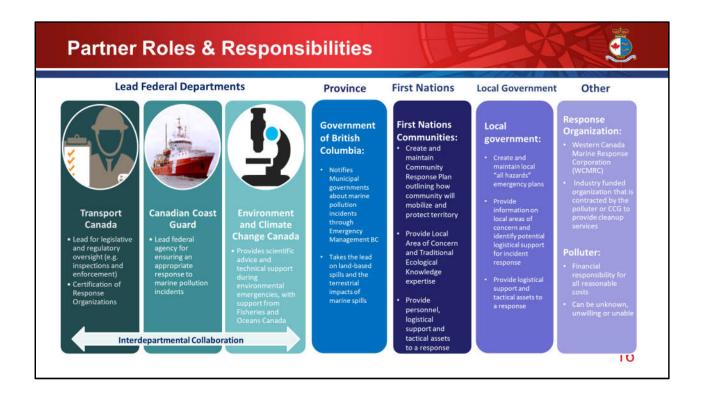

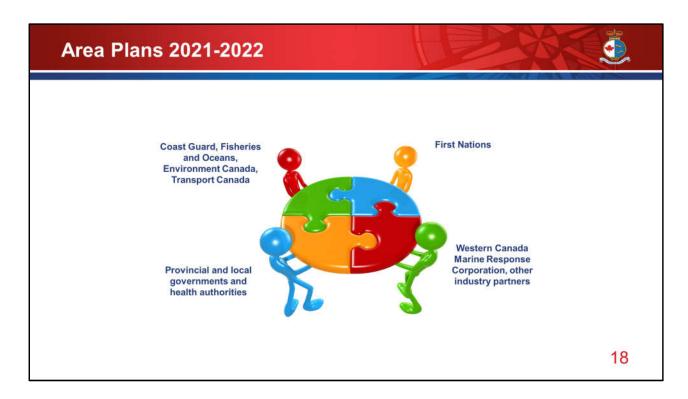

SUBJECT: In-person Local Trust Committee Meetings Update

PURPOSE: To provide an update to Executive Committee (EC) with regard to preparations for upcoming in-person Local Trust Committee (LTC) meetings.

BACKGROUND:

This is a summary note to address some of the key requirements that need to be met to conduct in-person meetings by the end of September. More detailed information relating to specific LTC meetings will be provided to EC members during the week of September 20.

We have had conversation over the last few days with the Ministry of Municipal Affairs confirming our masking and vaccine passport requirements for meetings.

In-Person Meetings - After September 28, 2021

Legislative Changes

- As of September 29, 2021 Ministerial Health Order 192 which allows trust bodies to conduct regular meetings electronically will cease to be in effect;
- Islands Trust has recently received an amendment to its *Electronic Meetings Regulation* which will allow regular meetings to be held electronically, in addition to special meetings;
- The new regulation will not be in force until September 29th at which time trust bodies can start amending their procedure bylaws if they want to hold some of their regular meetings electronically;
- Until these amendments are adopted, trust bodies will return to in-person meetings as of September 29th.
- Please note the most marked difference between what we have always know as a live LTC meeting (pre COVID) and an electronic meeting soon to allowed after September 29, that is that one or more of the decision makers may attend the meeting electronically.

Staffing

- The Electronic Meetings Regulation requires that an officer or staff person be physically present at a
 meeting location where the public may attend to hear or watch and hear an electronic meeting of a
 trust body. This means that even though a meeting is conducted fully electronically, we will still
 require a staffed meeting place for the public to attend;
- In-person meetings *may* also require an additional staff person to assist with seating arrangements and ensuring that mask requirements are followed;

• Some staff may be able to join a meeting either by phone or electronically to participate and provide advice.

Protocols for In-Person Meetings

- <u>All</u> Islands Trust meeting attendees 12 years and older, and including staff and trustees, will be required to wear a mask for the duration of a meeting in accordance with the September 2nd Provincial Health Order on Face Coverings;
- Through the September 10th Provincial Health Order on events and gatherings Islands Trust
 meetings, as well as public engagement sessions and workshops like those anticipated for Trust
 Policy Statement review are exempt from the requirement for attendees to show proof of
 vaccination; this exemption extends to meetings held in community halls, recreation centres and
 other public facilities;
- The maximum number of people allowed in our indoor meeting places is limited to 50 persons or 50% of the seating capacity whichever is greater;
- Since we're in step 3 of the BC Restart plan, physical distancing for seating is no longer a requirement. However, we could include some form of distancing requirement in the Islands Trust COVID 19 safety plan that would apply to meetings.
- Some meeting venue operators have expressed concerns about the vaccination passport
 requirement as it applies to Islands Trust meetings. Ministry staff suggested that these operators be
 referred to the public health order on events and gatherings, which shows the local government and
 Islands Trust exemption from this requirement. Operators can also contact Ministry staff to confirm
 the exemption

Technology

Islands Trust now has one portable kit of equipment to record and, if possible, live stream meetings. Three more kits are on order. The intention with these is that local trust committee chairs will transport and set up the meeting hardware. Once these are in place we will be recording and broadcasting LTC meetings AND undertaking trials for more enhanced interactive ZOOM meetings where connectivity allows.
