Chair Graham called the meeting to order at 10:31 am.

3. MINUTES

3.1 Gambier Island Local Trust Committee Meeting Minutes dated April 12, 2012

The minutes of the Gambier Island Local Trust Committee meeting dated April 12, 2012 were adopted as amended by consensus, with the following changes:

- Delete on page 1 under "Present" the listing of the delegation
- Page 1: Change "six (6)" to "seven (7)" members of the public in attendance
- Page 3, paragraph 4, last sentence should read: "The parking issue has been going on for 15 years."
- Item 7.1: insert "Hardwick" after all five notations of "Nystedt"
- Item 8, paragraph 5, replace "term" with "budget year"
- 3.2 Section 26 Resolutions Without Meeting

There were no Resolutions Without Meeting.

3.3 Gambier Island Advisory Planning Commission Minutes

There were no Gambier Island Advisory Planning Commission minutes.

Planner Zupanec advised that the new Advisory Planning Commission had met. The chair is Joyce Clegg, Al Haley is Vice Chair, and Secretary is David Walker. The Advisory Planning Commission will meet again in two weeks to determine the recommendation for the Local Trust Committee for the sustainability brochure.

4. BUSINESS ARISING FROM MINUTES

4.1 Follow-up Action List dated May 14, 2012

Planner Zupanec provided an update on the Follow-Up Action List dated May 14, 2012.

Planner Zupanec responded to Trustees' questions about the Riparian Areas Regulation.

Trustee Stamford recommended that information be sent from Islands Trust to all property owners about the Riparian Areas Regulation and expectations in regards to the Riparian Areas Regulation.

Chair Graham advised that an Islands Trust Planner had been assigned to collaborate with trustees on this.

5. CHAIR'S REPORT

Chair Graham reported on his attendance at the annual meeting of the Association of Vancouver Island and Coastal Communities. Topics presented at the meeting included the Island Corridor Rail Line, changes in operations of the Agricultural Land Commission, and aquaculture management. A number of resolutions were made, including endorsement of decriminalization of marijuana.

The Islands Trust Executive Committee continues to look at items and materials pertaining to the strategic plan.

Recently Trustee Hagedorn and Chair Graham attended a Local Planning Committee meeting by phone, and looked at emerging energy technology and at shoreline mapping.

6. TRUSTEES' REPORT

Trustee Stamford attended the Sunshine Coast Regional District Corporate and Administrative Services Committee meeting on April 26, 2012 to provide support for the Gambier Community Association Grant-In-Aid application for parking funds.

At a Programs Subcommittee meeting in Ladysmith, members discussed how the municipalities and Local Trust Committees can work together. The meeting also focused on the Community Stewardship Award nominations. It appeared that preliminary recommendations included an individual from the Gambier Local Trust

Area.

The public information meeting held by BURNCO May 23, 2012 in West Vancouver, attended by both Local Trustees, received a large turnout. On May 25, 2012 Trustee Stamford would be joining a group that includes the Howe Sound Community Forum group, representatives from the Sunshine Coast Regional District, McNab Creek Estates and other groups, for a site visit with BURNCO at McNab Creek.

Trustee Stamford announced there would be a Transport Canada meeting at the ramp at New Brighton that would include a divestiture group. There had been no new information about the divestiture issue.

Trustee Hagedorn attended the recent Planning Committee meeting via teleconference. The trustee noted that there is financial support for small scale renewable energy offered by BC Hydro. The annual meeting with Keats Island Roads Committee is scheduled for June 1, 2012. Trustee Hagedorn attended the recent Advisory Planning Commission meeting. She stated her appreciation for the installation of the new ramp at New Brighton.

Trustee Hagedorn had received a number of emails pertaining to the BURNCO issue. Staff advised the trustee to forward these to BURNCO and copy to the Sunshine Coast Regional District Planner assigned to the project.

10.1 GM-LUB-2011.2 (Associated Islands Land Use Bylaw Review Project)

10.1.1 Island Visits

Planner Zupanec informed the Local Trust Committee that a revised version of the draft Associated Islands Land Use Bylaw was being worked on for the July 5, 2012 meeting.

Planner Zupanec advised the Local Trust Committee the she did not plan to do any site visits for the duration of the initial draft, other than the two Open Houses on the Draft Associated Islands Land Use Bylaw, in West Vancouver on July 13, 2012 and in Sechelt on July 20, 2012.

Members of the Local Trust Committee agreed to wait until after these public consultations before doing any site visits, which likely would happen later in the summer.

Trustee Hagedorn highlighted points from a BURNCO flyer from the event. The project would create twelve jobs, of which one person would live in McNab Creek. A lot of concerns had been raised at the meeting about dust control.

SJ provided an overview of the purpose of the Commission together with a brief orientation. Items of note as follows:

 - 4.1 May 1st Referral re Draft Sustainability

- SJ presented overview of Referral package. Four (4) Local Trust Areas have developed a Sustainability Checklist to assist in the Building Permit process. Gambier Local Trust Area has been discussing this issue over last couple of years and have forwarded to the Commission for review. The APC should discuss if the document is worthwhile to bring to the community and if so, what does it look like. A Recommendation will be forwarded to the Local Trust Committee and our Recommendation is required by June 21st
- o Of the four samples reviewed most are in Draft form and not a formal document.
- All are linked and tied to the permitting process and are/ will be a mandatory part of the process
- Documents are available at the "front desk" where permits are discussed
- O JH noted she has had discussions with Sunshine Coast Regional District and they support the concept of a sustainability document. The development of any document could be a joint effort. Document may assist both Regional Districts –Sunshine Coast and Metro Vancouver.
- JH has not discussed issue with Metro.

4.2 General Discussion

- 4.2.1 There was general discussion on several issues relating to the Referral
- 4.2.2 Is it a worthwhile document?
 - 4.2.2.1 Consensus that "checklist" may not be the best format / title however an information document on sustainability and building on the islands may be of some use to the general public.
 - 4.2.2.2 Document should be helpful to both new and renovation projects
 - 4.2.2.3 Document and its content should not be mandatory
 - 4.2.2.4 Document needs to be available earlier in the project than the building permit process
- 4.2.3 When and how document is distributed?
 - 4.2.3.1 Many thoughts and ideas with no consensus
 - 4.2.3.2 Ideas included Realtors, General Contractors, Islands Trust, Local Trust Area and island specific web sites, and newsletters
- 4.2.4 What would document look like?
 - 4.2.4.1 Should address design stage, construction stage and living on a reduced footprint.
 - 4.2.4.2 Various islands in the Trust Area may have unique or specific issues
 - 4.2.4.3 Of the four (4) reviewed Lasqueti Island looked best suited to an information only document

4.3 Conclusions

- 4.3.1 A sustainability document may be of value to owners of new development and renovation projects in the Gambier Trust Area
- 4.3.2 Any document should NOT be linked to permitting process and should be available as early as possible in the planning and development process.
- 4.3.3 Document should be educational and an information only package
- 4.3.4 Any mandatory sustainability related issues need to be addressed in the Land Use Bylaws and other building codes and not this package
- 4.3.5 Document should be available as early as possible in the process
- 4.3.6 Document should address Sustainability at Large and potentially highlighting issues specific to each island within the Trust Area.
- 4.3.7 Of the four Drafts reviewed Lasqueti Island would be a good "base". Action Item—SJ to provide "word document" of Lasqueti Island document.

4.4 Next Steps

- 4.4.1 Chair proposed members review material and, based on Lasqueti draft, review generic / motherhood issues and provide any comment as to island specific concerns / issues.
- 4.4.2 Give consideration to and provide input as to when the document should be available and to how document could / should be distributed to the public

4.5 Next Meeting

- 4.5.1 General discussion with respect to scheduling a regular monthly meeting and cancel if no "Referrals" are forwarded.
- 4.5.2 Venue at Gibsons Library is acceptable to all Commission members

A BYLAW TO AMEND GAMBIER ISLAND OFFICIAL COMMUNITY PLAN BYLAW 73, 2001
