Chair Stamford called the meeting to order at 10:00 a.m. and acknowledged that the meeting was being held virtually from locations across the treaty and unceded territories of the Coast Salish people.

#### 5. BUSINESS

#### 5.1 Items for Approval

5.1.1 Sandy Beach Nature Reserve Covenant (Gambier) – Request for Decision

The ITC Ecosystems Protection Specialist presented the request for the decision to Board members and highlighted there a BC Hydro right of way on the property.

Discussion ensued on management plans for areas of cultural significance, coordination with First Nations, and eliminating barriers to traditional use for lands by First Nations, including collection of plants and hunting.

#### ITC-2022-040

#### It was MOVED and SECONDED,

that the Islands Trust Conservancy Board directs the Chair to sign the Conservation Covenant agreement among TLC The Land Conservancy of British Columbia, the Sunshine Coast Conservation Association, and the Islands Trust Conservancy, over the land identified as Lot 1 District Lot 696 Group 1 New Westminster District Plan EPP89532 (PID: 031-259-731) and known as Sandy Beach Nature Reserve.

#### CARRIED

#### 5.1.2 Enchanted Forest Covenant Tree Planting (South Pender) - Request for Decision

The ITC Covenant Management and Protections Specialist presented the request for decision to Board members.

Discussion ensued on appropriate tree species planted to adapt to climate change, maintenance required for successful habitat restoration, and adding a request for reporting on the project to the resolution.

Board members discussed the *Islands Trust Cultural Protocol for Chance Finds and Ancestral Remains* document and requested to review the document. Manager Emmings noted the document is under development, but has been shared with contractors. Manager Emmings will follow up with Director Frater regarding sharing the protocol.

#### 5.1.3 ITC Budget Request - Request for Decision

The ITC Manager presented the request for decision to Board members and highlighted that an approximate 13% increase is proposed. The increase is comparable to other Islands Trust departments and includes BCGEU tentative agreement salary increases.

The ITC Manager noted that, although the Board requested inclusion of budget cases for Property Management software and Contact Management Software at its July meeting, these have not been provided because they will be addressed by Information Systems and the Executive Committee in their respective budget requests. The ITC Manager will keep the Board informed on the progress of these budget items.

Discussion ensued on the budget amounts for First Nations engagement and contact management software upgrades.

#### 5.1.5 Nighthawk Hill NAPTEP Covenant Addition (North Pender) - Request for Decision

The ITC Ecosystems Protection Specialist presented the request to Board members.

#### ITC-2022-045

that the Islands Trust Conservancy Board approves the revised Nighthawk Hill NAPTEP Covenant (NIHN) and authorizes the Chair to sign the NIHN with Andreas Nowak and Mary Reher, over a portion of the land described as Lot 38, Section 7, Pender Island, Cowichan District, Plan 32261, Except Part in Plan 35333, PID 001-081-110, subject to receiving an updated Baseline Documentation Report that is acceptable to the Islands Trust Conservancy Manager, and directs staff to register the covenant.

#### 5.2 Items for Discussion/Direction

#### 5.2.1 <u>COP15, Convention on Biological Diversity</u>

Trustee Smith will attend the Conference of the Parties (COP) to the UN Convention on Biological Diversity (CBD) December 7–19, 2022. COPs take place every 2 years, but every 10 years a larger COP takes place where the international biodiversity targets for the next ten years are set. This meeting is one of those every 10 year meetings. The meeting is taking place in Canada and the Government of Canada will have a Canadian pavilion. Trustee Smith put in a proposal to include information on the biodiversity climate change nexus, and asked if ITC would want to be a partner? Trustee Smith will make the presentation and could include a slide on the unique work we are doing at ITC.

Board members expressed support and suggested Trustee Smith work with Manager Emmings to create an ITC slide to increase ITC profile.

#### 5.2.2 ITC Board Elections, Appointment & Orientation – Briefing

The ITC Manager provided an update on the local government election, noted ITC staff are preparing orientation materials for incoming trustees, and welcomed suggestions from ITC Board members regarding the orientation process and materials.

Discussion and suggestions included:

- Provide a copy of the ITC slides from the Union of BC Municipalities 2022 highlights presentation (page 7 of the breakfast binder) to new trustees.
- Post reference documents for elected trustees on WebDAV in an organized fashion, easy to find at a later date.
- Include an ITC promotional brochure with the Islands Trust welcome letter to newly elected trustees.
- Provide a copy or link to ITC Annual Report.
- Begin the impression that ITC is designed to grow, not that it is a subset of Island Trust, equivalent arm, separate from Trust Council.
- Provide orientation to elected trustees about what ITC is prior to giving notice of intent. Recommend this to the Management team.
- Keep the first ITC agenda light with focus on orientation items not covered at Trust Council.

#### 5.2.3 Sandy Beach Nature Reserve Management Plan (Keats) – Briefing

The ITC Property Management Specialist provided an update on a response from the Siwxwú7mesh (Squamish) Nation recommending wording changes to the Sandy Beach Nature Reserve Management Plan and is working on clarifying the changes correctly.

Chair Stamford requested clarification on the correct name for Keats Island for Gambier Island Local Trust Committee meetings.

#### 5.4.6 <u>Executive Committee Update</u>

Trustee Fast commented that she presented an ITC slide at the recent Islands Trust breakfast at the invitation of Chair Luckham. Trustee Patrick and Trustee Fast represented the Executive Committee. The workshop was positive and well attended.

Trustee Fast advised there is an Executive Committee meeting October 5, 2022, and the agenda will include discussion of trustee orientation. There is another orientation session planned for January. The Executive Committee agenda is posted to the website for those interested.

#### 5.4.7 <u>Financial Planning Committee Update</u>

Chair Stamford advised the Financial Planning Committee is expecting increases in budget due to the tentative BCGEU agreement and several project requests, and is currently developing the 2023/24 budget. There is a meeting scheduled for October 12, 2022.

#### 5.4.8 <u>Trust Council Update</u>

The ITC Manager advised the Board that Trust Council received two noteworthy ITC-related items:

- 1) Referral of the draft ITC Plan: Trust Council had no comments; and,
- 2) NAPTEP Fees Bylaw and Guidelines: an amended NAPTEP Fees Bylaw was given three readings and guidelines for Executive Committee sponsorship of NAPTEP fees were approved. This will allow the Board and applicants to NAPTEP to apply to the Executive Committee for waiver of NAPTEP fees.

#### 5.4.9 <u>Trustee Roundtable</u>

Trustee Fast thanked everyone for their work, commented it has been such a pleasure to be part of the Board, and provided an update on the following:

- Bowen Island Council passed a conservation development policy and a site alteration bylaw.
- Metro Vancouver is proposing to wrap around the new Cape Roger Curtis Nature Refuge, that the Bowen Island Conservancy runs, with a big 240 acre park, the remains of the former development. This has become an election issue on Bowen Island and people are concerned about camping, a potential for transportation issues, due to cars on the ferry and roads.
- Bonny Brokenshire, Manager of Environment, Parks Planning and Bylaw Services, is moving on to work with the City of Vancouver. At some point there will be a new contact person for the environmental liaison.
- Heron watch program many biologists and volunteers have retired or moved on. Trustee Fast will work on developing new contacts after the election.

Trustee Smith thanked everyone for their work, noted her one-year anniversary on the board, and provided an update on Saturna Island's Cetacean Watch Program, noting Galiano has also joined.

Trustee Adams thanked Board members, staff, and especially Chair Stamford for keeping meetings on track. Trustee Adams commented on the conservation work happening on Salt Spring and noted the Vital Signs Report for Salt Spring Island, to be published this month, could be helpful to staff.

Trustee Fenton provided an update on work of the Thetis Local Trust Committee, work with Frist Nation's communities, and thanked everyone for an amazing four years as a Trustee. He also advised he is running again for the Thetis Island Local Trust Committee and hopes to return to the ITC Board.

Chair Stamford thanked Board members and staff, commented it has been an amazing eight years working with the Islands Trust Conservancy, and advised she has been acclaimed as a Trustee for the Gambier Island Local Trust Committee and as Regional Director for Sunshine Coast. She is not intending to run for ITC for the 2022-2026 term.

The ITC Manager provided highlights of the last four years to Board members and thanked them for their support.

SUBJECT: ITC Plan Review and Approval

**RECOMMENDATION(S):** That the Islands Trust Conservancy Board approve the draft 2023-2025 Islands Trust Conservancy Interim Plan and direct staff to forward it to the Minister of Municipal Affairs by December 31, 2022, for review and approval.

**1 PURPOSE:** To provide the Islands Trust Conservancy (ITC) Board with a draft ITC Three-Year Plan for review and approval to forward to the Minister of Municipal Affairs before the end of 2022.

#### 2 BACKGROUND:

The *Islands Trust Act* requires that the ITC prepare and submit to the Minister, at least once every five years, a Trust Fund Plan (ITC Plan), including policies on acquisition, management, and disposal of property, investment of money, goals for major acquisitions, and other matters as required.

The ITC Plan is administrative in nature, and includes ITC policies on land acquisition, management and disposition of land, and investment of funds. More recently, it has also summarized the goals of the draft Regional Conservation Plan<sup>1</sup>.

At its May 2022 meeting, the ITC Board considered a three-year interim ITC Plan and passed the following resolutions.

#### ITC-2022-023

#### It was MOVED and SECONDED,

that the Islands Trust Conservancy Board approve the draft ITC Three-Year Plan and direct staff to refer it to local trust committees, the Bowen Island Municipality, Trust Council and First Nations and to bring a final draft to the Board for approval at its November 2022 meeting.

ITC staff began an internal referral process for the ITC Plan in July 2022 and referred the ITC Plan to First Nations governments and agencies in September 2022.

#### Internal Referral Responses:

Staff referred the ITC Plan to Trust Council, Bowen Island Municipal Council and local trust committees. The following responses were received:

With the exception of the Ballenas-Winchelsea Local Trust Committee, which hasn't met since June 29, 2022, all other local trust committees and Trust Council received the ITC Plan without comments.

#### First Nations Referral Responses:

The ITC Plan and draft First Nations referral correspondence were reviewed by Ministry of Indigenous Relationships and Reconciliation (MIRR) staff prior to being sent.

On September 29, 2022, ITC sent out referrals to thirty-seven First Nations governments and referral agencies in the Islands Trust Area. Because of email bounce backs and referral requirements, the Skwxwú7mesh (Squamish) Nation, Tla'amin (Sliammon) First Nation, and Lyackson First Nation received referrals on October 6, 2022 and the Ts'uubaa'asatx First Nation (Lake Cowichan First Nation) received its referral on October 25, 2022. ITC staff also missed a bounce back from x<sup>w</sup>mə $\theta$ k<sup>w</sup>əýəm Musqueam Indian Band and did not send the referral through until November 14 with apologies and an offer to discuss late incorporation of feedback. ITC staff requested all responses by November 15, 2022.

#### Discussion of First Nations Responses

To date, ITC has only received three full responses to the referral; however, consideration of these responses trigger potentially major changes to the way that ITC does its work. In particular, requests that ITC only acquire land where First Nations have provided consent to the acquisition. It is unclear if this request extends to conservation covenants. These requests require significant analysis and staff will engage with staff at the Ministry of Municipal Affairs to discuss next steps. It is likely that consideration of these requests cannot be properly done within the statutory deadline for the Board to submit the plan by December 31, 2022. Staff will convey First Nations feedback to the Minister for consideration.

#### **3** IMPLICATIONS OF RECOMMENDATION:

**ORGANIZATIONAL:** The ITC Plan will direct the work of the ITC for the next three years. In particular, a focus on First Nations engagement will require a portion of each staff member's time to be diverted from other work, including, but not limited to, land negotiations and communications/engagement work with other partners. Staff will bring a proposal to the Board with work plan recommendations to accommodate the Board's direction at the next ITC Board meeting.

**FINANCIAL:** Approval of the ITC Plan will have minimal financial implications, but may require some graphic design following the approval of the Minister, likely under \$1,000. Implementation of the plan will require funds to properly engage with First Nations over the next three years as the Board works towards the 2026-2030 plan. The ITC Board has approved a business case for \$10,000 to go to Trust Council to assist with these costs and funding from other budget areas, such as the Conservation Planning and Securement budget may be allocated to assist with engagement. There may also be legal costs associated with working with First Nation governments and agencies. These costs are anticipated to be under \$5,000. ITC staff will work within current budgets to accommodate costs.

#### **POLICY:** None anticipated.

**IMPLEMENTATION/COMMUNICATIONS:** Staff will forward the approved ITC Plan to the Minister of Municipal Affairs for consideration and approval. Once approved, staff will update the website to reflect the new ITC Plan and will communicate out to Trust Council, local trust committees, Bowen Island Municipality and First Nations to share the new ITC Plan. The ITC Plan will also be shared via eNews to the ITC subscribers and shared via social media.

**FIRST NATIONS:** The ITC Plan includes a clear direction for increased engagement of First Nations. It is hoped that this increase in engagement will result in stronger relationships with First Nations in the region.

**CLIMATE CHANGE:** The ITC Plan includes some updates to explicitly note that ITC will collect and secure information related to impacts of climate change on the Islands Trust Area, including requiring that Management Plans include a description of anticipated change of ecosystems over time and recommendations for mitigation of and adaptation to climate change.

**OTHER:** At the May 2022 ITC Meeting, the ITC Board passed the following resolution:

#### ITC-2022-025

#### It was MOVED and SECONDED,

that the Islands Trust Conservancy Board direct staff to prepare a Project Charter for the next ITC Five-Year Plan (2026-2030) with an emphasis on First Nations engagement.

ITC staff will bring a Project Charter to the ITC Board early in 2023 for review.



# I. TERRITORIAL ACKNOWLEDGEMENT

Islands Trust Conservancy respectfully acknowledges that the lands and waters that encompass the Islands Trust Area have been home to Indigenous peoples since time immemorial and that their deep connection to the islands continues to this day. We are committed to reconciliation, to upholding the rights of Indigenous peoples, and to working together to preserve and protect this ecologically, culturally, and spiritually significant region in the Salish Sea.

The Islands Trust Area is located in the **treaty and territorial lands** and waters of the BOKECEN, <u>Cowichan Tribes</u>, K'omoks, Lyackson, MALEXEŁ, Qualicum, scawa0an, salilw\_atal, SEMYOME, shishalh, Skwxwu7mesh, Snaw-naw-as, Snuneymuxw, Songhees, Spune'luxutth', STAUTW, Stz'uminus, la'amen, Ts'uubaa-asatx, Wei Wai Kum, We Wai Kai, W JOLEŁP, WSIKEM, Aelaltxw, Xwemalhkwu, Xwsepsum, and x'ma0kray.

### 2. INTRODUCTION

Islands Trust Conservancy<sup>1</sup> manages over 1,375 hectares of diverse island ecosystems in 113 protected areas, in collaboration with private landholders, land trusts and other conservation partners. Islands Trust Conservancy recognizes that the ability to protect these island ecosystems is possible because of the thousands of years of stewardship by First Nations with interests in the lands and waters of the Salish Sea, which has created a lasting natural legacy in the islands.

Islands Trust Conservancy was created by the Province of British Columbia in 1990 as a regional land trust and conservation arm of the Islands Trust to protect in perpetuity some of the most ecologically and culturally significant places in the Islands Trust Area. To do so, Islands Trust Conservancy works closely with partners to protect sites through land donation, conservation covenants, land purchase and public education.

Islands Trust Conservancy plays an important role in preserving and protecting the unique and fragile ecosystems found in the <u>Salish Sea</u>. The area is among the most biologically diverse regions in British Columbia and is globally significant. Within the Islands Trust Area, there are a total of 193 red-listed (extirpated, endangered, or threatened) species (25% of the provincial total) and 163 blue-listed (special concern) species (14% of the provincial total) (BC Conservation Data Centre, 2022).<sup>2</sup> There are also a high proportion of the province's red and blue-listed ecological communities.

The Islands Trust Area supports some of Canada's last remaining Garry oak ecosystems and the associated rare plants, mosses, butterflies and reptiles. Island coastlines support eelgrass meadows, <u>clam beds and other shellfish populations</u>, forage fish habitat, glass sponge reefs and other extraordinary marine environments. These numerous rare and endangered species and ecosystems will not survive unless sufficient habitat is protected and carefully managed for its ecological integrity <u>and biodiversity</u>. Islands Trust Conservancy's work encouraging and assisting private landholders to protect ecologically valuable land in this region is vital to the provincial government's efforts to protect these important and imperiled ecosystems.

Since the adoption of the 2017-2022 Islands Trust Conservancy Plan, Islands Trust Conservancy has deepened its learning about the connection of Indigenous Peoples to the land and waters of the islands. Typically, Islands Trust Conservancy adopts five-year plans to guide its work; however, Islands Trust Conservancy has not had sufficient time to engage with First Nations governments and agencies regarding its strategic directions to be able to submit a five-year plan. Consequently, Islands Trust Conservancy has created an interim three-year plan that is substantively an update to the previous plan. The three-year plan will guide the work of Islands Trust Conservancy while it conducts early and meaningful First Nations governments and agencies and with support from the Ministry of Municipal Atlans, Islands Trust Conservancy hopes to create a Five-Year Plan that advances the objectives of the <u>United Nations Declaration on the Rights of Indigenous Peoples</u> (UN Declaration), clarities Islands Trust Conservancy's role under the *Declaration on the Rights of Indigenous Peoples Act* [SBC 2019] Chapter 44, and supports the outcomes in the provincial <u>Declaration on the Rights of Indigenous Peoples Action Plan</u> 2022-2027.

# 3. Islands Trust Conservancy Mandate, Mission and Vision

#### The Legislated Mandate of Islands Trust Conservancy

In 1974, the Province of British Columbia recognized the islands between Vancouver Island and the mainland as a special place within the province where the unique beauty, rural character and rare ecosystems should be protected from overdevelopment. Through the *Islands Trust Act*, the province established the Islands Trust, with the following mandate (known as the Object of Islands Trust):

To preserve and protect the trust area and its unique amenities and environment for the benefit of the residents of the trust area and of British Columbia generally, in cooperation with municipalities, regional districts, improvement districts, First Nations, other persons and organizations and the government of British Columbia.<sup>3</sup>

In 1990, through the enactment of a section of *Islands Trust Act*, Islands Trust Conservancy (at that time, Islands Trust Fund) was established as a conservation land trust to assist in carrying out the "preserve and protect" mandate. Part 6 of the *Islands Trust Act* establishes the corporate status, responsibilities, and governance structure of Islands Trust Conservancy.

Islands Trust Conservancy is one of 16 corporate entities<sup>4</sup> charged to uphold the Object of Islands Trust. It carries out the preserve and protect mandate through the conservation of land as nature reserves, nature sanctuaries and, conservation covenants, and through public education.

#### Under the Islands Trust Act (Section 44)

- Islands Trust Conservancy must prepare and submit to the Minister, at least once every five years, a plan for the trust fund respecting
  - a) policies on acquisition, management and disposal of property of the trust fund,
  - b) policies on investment of money of the trust fund,
  - c) goals for major acquisitions of property by the trust fund, and
  - d) other matters as required by the Minister
- 2. Islands Trust Conservancy must not, without the prior approval of the Minister, acquire, hold or dispose of land except in accordance with a trust fund plan under subsection (1) that has been approved by the Minister.

#### Islands Trust Conservancy Three-Year Interim Plan The Mission and Vision of Islands Trust Conservancy

The mission of Islands Trust Conservancy is to protect special places by encouraging, undertaking, and assisting in voluntary conservation initiatives within the Islands Trust Area.

The vision of Islands Trust Conservancy is for a network of protected areas that preserve in perpetuity the natural systems of the islands in the Salish Sea.

#### **Reconciliation Declaration**

In July 2019, Islands Trust Conservancy approved a Reconciliation Declaration:

Islands Trust Conservancy acknowledges that the islands and waters that encompass the Salish Sea have been home to Indigenous Peoples since time immemorial. We recognize that we are all intertwined in the ecosystems that are the lands, waters, culture, and ecology that embody this place.

Islands Trust Conservancy will strive to create opportunities for knowledge-sharing, understanding and collaboration as people come together to preserve and protect the special nature of the islands within the Salish Sea.

Islands Trust Conservancy is committed to the protection and preservation of this place through processes that respect and honour reconciliation and mutually respectful relationships with Coast Salish Indigenous Peoples. We express our recognition for the past, present, and future stewardship and knowledge that has been shared by Indigenous Peoples and are humbled and grateful.

### 4. Goals and Objectives of Islands Trust Conservancy

#### **Building on Achievements**

#### Protected Lands

Since its inception in 1990, Islands Trust Conservancy has protected 1,375 hectares (3,400 acres) of ecologically-significant natural area on the islands. As of November 2022, Islands Trust Conservancy manages 34 Nature Reserves, and works with island landholders to steward 79 conservation covenants for a total of 113 protected areas. Twenty-eight of these protected places are certified as Ecological Gifts by Environment and Climate Change Canada.

In the next three years: Islands Trust Conservancy will continue to refine the knowledge used for its decision making by developing a renewed 10-year Regional Conservation Plan to ensure that the organization's time and resources are directed towards high-priority land protection projects.

Islands Trust Conservancy will continue to pursue new and innovative sources of funding to ensure that it can seize time-sensitive land securement opportunities and prevent further loss of the rare and fragile ecosystems of the Islands Trust Area. Islands Trust Conservancy also intends to increase funding available for property management and restoration of its protected lands.

See Appendix A for a list of properties protected by Islands Trust Conservancy.

#### Collaboration

Islands Trust Conservancy works in partnership with land trusts, conservation groups, First Nations <u>governments and agencies</u>, parks agencies and others focused on conservation in the region. Staff participate in the Coastal Douglas-fir and Associated Ecosystems Conservation Partnership, the Land Trust Alliance of British Columbia, and the Species and Ecosystems at Risk Local Government Working Group to further the organization's conservation mandate.

Islands Trust Conservancy supports and enhances the capacity of the local island-based land trusts by providing grants from its Opportunity Fund, working collaboratively on projects, and facilitating education and networking opportunities. Islands Trust Conservancy's Opportunity Fund is funded by private donations and has provided more than \$125,000 in grants to local land trusts, helping protect more than 589 additional hectares of land, since it was created in 2005.

In the next three years: Islands Trust Conservancy will seek to establish and deepen relationships with First Nations governments and agencies and will work towards building trust by finding opportunities to collaborate with First Nations to integrate Traditional Ecological Knowledge into management planning, reconnect youth with island ecosystems and other mutually beneficial initiatives. Islands Trust Conservancy will also meaningfully engage with First Nations governments and agencies in the development of the 2026-2030 plan to create a Five-Year Plan that advances the objectives of the United Nations Declaration on the Rights of Indigenous Peoples (UN Declaration) and the supports the outcomes in the provincial Declaration on the Rights of Indigenous Peoples Action Plan 2022-2027. #### Financial Sustainability

The administration of Islands Trust Conservancy is funded by Islands Trust Council, through property taxes collected from the residents and landholders of the Islands Trust Area.

Land securement and any other projects outside of core operations must be funded through external sources, including grants and private donations.

Grants: Because of the density of rare species found in the Islands Trust Area, Islands Trust Conservancy has been successful in negotiating over \$600,000 in federal funding between April 2020 and March 2023 to support land protection and management for species at risk. Islands Trust Conservancy intends to work with the Government of Canada to continue conservation for species at risk.

Private Donations: To augment its ability to protect and manage land, Islands Trust Conservancy approved a Fund Development Strategy in early 2020. To support the Strategy, a part-time Strategic Fund Development Specialist position was created in 2022. In 2022, Islands Trust Conservancy was successful in raising over \$100,000 in donations, including being the recipient of two bequests.

Current Funds: Islands Trust Conservancy holds three geographically-restricted funds dedicated to land acquisition – the Lasqueti Island Acquisition Fund, the Gambier Island Acquisition Fund, and the Thetis Island Acquisition Fund – and has guidelines to assist with the future development of other geographically restricted funds. Additionally, Islands Trust Conservancy has a Covenant Management and Defense Fund, and Property Management Fund and two property-specific land management endowments.

*In the next three years*: The board will continue to promote legacy gifts as a way to fund the protection and stewardship of ecologically significant lands in the region.

#### Encouraging Private Land Stewardship

Islands Trust Conservancy's innovative tax incentive program for private landholders to place conservation covenants on their properties, the Natural Area Protection Tax Exemption Program (NAPTEP), provides a permanent 65% reduction on property taxes on the portion of an eligible property protected by a conservation covenant.

In the next three years: Islands Trust Conservancy will continue to promote its programs to island landholders, focusing its outreach efforts on the highest priority landscapes. Islands Trust Conservancy Board will welcome conversations with provincial, federal and First Nations governments about new or innovative tools that might motivate increased land stewardship in this region and will look to these governments to partner on such programs.

#### Planning for Regional Conservation

In January 2018, Islands Trust Conservancy Board approved a ten-year Regional Conservation Plan. The Regional Conservation Plan is the tool used by Islands Trust Conservancy to focus its resources on areas with the highest biodiversity values and greatest need for conservation. Islands Trust Conservancy has designed the Regional Conservation Plan as an information resource for citizens and organizations working towards conservation of biodiversity within the Islands Trust Area.

Based on scientific information and other forms of knowledge, the Regional Conservation Plan identifies areas of interest for conservation within the Islands Trust Area and strategies for achieving better levels of land conservation. Some of the strategies involve land acquisition and conservation covenants with willing landholders. Other strategies involve working with First Nations, partner agencies, local trust committees and Bowen Island Municipality to increase our knowledge base, encouraging protection of ecologically significant land within the Islands Trust Area and managing existing conservation lands effectively. #### Goals of the 2018-2027 Regional Conservation Plan

The 2018-2027 Regional Conservation Plan sets out four high level long-term goals that reflect the enduring ambitions of Islands Trust Conservancy to work with island landholders and conservation partners to protect the rich biodiversity of the Islands Trust Area:

1. Identify, investigate and communicate about important natural areas to generate action on conservation priorities

To contribute to effective conservation of biodiversity and ecological integrity in the Islands Trust Area, Islands Trust Conservancy needs an understanding of the status of ecosystems and species in the region<u>including an</u> <u>understanding of the impacts of climate change on the Islands Trust Area</u>. Islands Trust Conservancy manages over 1,375 hectares of land and can use data to improve and inform its land <u>acquisition and</u> stewardship <u>practices</u>. Islands Trust Conservancy will continue to invest in research and data acquisition that supports the conservation of island ecosystems <u>as well as preservation of archaeological & indigenous cultural features</u>.

2. Strengthen relationships with First Nations to identify and collaborate on shared conservation goals

The Islands Trust Area is in the territories of many First Nations. As part of its current practice, Islands Trust Conservancy invites comment from First Nations in management planning processes and refers public conservation proposals to First Nations <u>governments</u> where archaeological sites are identified. Islands Trust Conservancy seeks to <u>gain support of First Nations governments and to</u> establish and deepen relationships with First Nations <u>governments and agencies</u>. <u>Jslands Trust Conservancy</u> will work towards building trust and finding opportunities to collaborate with First Nations <u>governments and agencies</u> on projects and policy development where there are opportunities for shared benefits.

3. Continue to secure and manage Islands Trust Conservancy lands and conservation covenants to maximize ecological integrity

The core work of Islands Trust Conservancy is to maintain and contribute to protected area net-works which preserve ecological function and high levels of biodiversity in the Islands Trust Area. Islands Trust Conservancy will continue to acquire new nature reserves and conservation covenants as well as use other tools for conserving nature while ensuring that it cares for the lands that it is trusted to manage. Where conservation areas have the potential to protect archaeological sites and areas of cultural significance, Islands Trust Conservancy will work to respectfully manage these important cultural resources. Securing adequate funding to pursue new acquisitions as well as manage all protected lands responsibly will be an area of considerable focus for Islands Trust Conservancy. Land securement and management activities are also expanding to include meaningful engagement with First Nations and mitigation and adaptation to the impacts of climate change.

4. Continue to build internal and shared organizational strength and resilience to ensure long-term nature conservation in the Islands Trust Area

Islands Trust Conservancy was established in 1990. It has been a consistent presence in conservation of species and ecosystems in the Islands Trust Area for almost thirty years. As it moves into the fourth decade of its work, Islands Trust Conservancy will ensure that it is can responsibly care for its management responsibilities and participate effectively in partnership opportunities into the future. It will also work to be resilient enough to gracefully navigate change, both on the landscape and as an organization.

## 5. ISLANDS TRUST CONSERVANCY POLICIES

Below is a summary of key Islands Trust Conservancy policies affecting the public interest. A full list of policies, hyperlinked to the Islands Trust website, can be found in Appendix B.

#### Section 1: Fundraising, Investment and Financial Accountability

#### General Accounting

The financial transactions of Islands Trust Conservancy are managed using standard accounting procedures and are subject to an annual independent audit. The Audited Financial Statements of Islands Trust Conservancy are available on the Islands Trust website.

To ensure financial accountability, Islands Trust Conservancy will:

- · follow the procurement policy established by Islands Trust Council;
- require prior approval of the board for expenditures in excess of \$10,000 unless a prior resolution from the board approves a plan, project or policy authorizing such an expenditure;
- require all financial transactions related to approved projects to be authorized by the Islands Trust Conservancy Manager;
- direct the Islands Trust Conservancy Manager to act on behalf of the board to oversee the management of the bank accounts and investments of the board; and,
- · review an updated financial report at each regular board meeting.

Islands Trust Conservancy will not incur any liabilities without the prior approval of the Minister responsible for Islands Trust.

#### Fundraising and Investment of Funds

Islands Trust Council approves an annual budget for the administrative operations of Islands Trust Conservancy. This funding covers operating expenses including, but not limited to, board meetings and training, staff salaries and benefits, conservation planning, land and covenant negotiations, communications, fundraising, legal counsel and property management costs. However, the operating budget is not used for direct acquisition of properties (i.e. purchase costs). Accordingly, to purchase land or contribute to acquisitions by other agencies, Islands Trust Conservancy must raise additional funds. The *Islands Trust Act* provides Islands Trust Conservancy with the ability to raise funds in a variety of ways.

The board and staff will solicit funds for the purposes outlined in existing Fund Guidelines<sup>5</sup> and Fund Agreements<sup>6</sup>. Islands Trust Conservancy will not solicit funds for purposes outside of those approved in Fund Guidelines or Fund Agreements unless it has first reviewed and approved the additional fundraising activity. Islands Trust Conservancy currently manages ten funds.

Islands Trust Conservancy will not engage in commission-based fundraising, and will not employ contractors utilizing this method for fundraising activities. Islands Trust Conservancy will reserve the right to decline to accept a donation at its discretion.

Islands Trust Conservancy routinely requests cash endowments with land conservation projects associated with development applications. Islands Trust Conservancy invests these endowments only in accordance with the requirements of the *Trustee Act* for the investment of trust property by a trustee. The board ensures that it invests only in forms of property or security in which a prudent investor might invest, and which enable retrieval of the full investment if required.

Islands Trust Conservancy is a corporation that is, for all purposes, an agent of the provincial government, and accordingly is a qualified donee and can issue receipts for income tax purposes for donations. Islands Trust Conservancy is exempt from paying property taxes on its lands.

#### Section 2: Acquisition, Management and Disposition of Property

#### General

Under the *Islands Trust Act*, Islands Trust Conservancy can accept donations and grants of land, conservation covenants, other interests in land, cash, securities and other real property in support of the protection of the Islands Trust Area. Islands Trust Conservancy is an approved recipient of gifts of land and interests in land through Environment and Climate Change Canada's Ecological Gifts Program.

When considering proposals, the board will give priority to those proposals that protect larger areas of land, and may defer or decline smaller proposals. The board will only consider accepting covenants and land acquisitions of less than two hectares (4.9 acres) if specific significant features are present.

The board will assess the need for the ongoing management and future legal defense of conservation properties and may, as part of an approval, request or require an endowment or donation to cover management and defense costs associated with the land or covenant.

#### Land Acquisition

Islands Trust Conservancy will normally only consider the acquisition of lands that meet the Board's definition of Nature Reserve: an area that has been set aside because it has regionally significant natural ecosystems (landscape units with little or no human development) and may contain nationally and provincially identified ecosystems and species that are considered endangered, threatened or of special concern. The primary purpose of a Nature Reserve is the preservation and protection of the natural ecosystem. The size of a Nature Reserve should be sufficient to ensure that these ecosystems remain viable over the long term. Activities permitted on a nature reserve will have minimal impact on the land and in general will only include hiking and only in areas that are considered not sensitive to this activity. The location and extent of hiking trails will be determined through the management plan process.

Islands Trust Conservancy will not accept or acquire any lands where there is an obligation to maintain buildings or structures. The Conservancy may accept and acquire lands that have buildings on-site that can be removed or maintained at the board's discretion.

As a further measure of protection, Islands Trust Conservancy may develop and register a conservation covenant on each of its nature reserves if an appropriate conservation agency can be found to hold the covenant and if the values on the land warrant the investment of staff time and legal fees. Islands Trust Conservancy will not accept land that is subject to a rent charge'.

#### Conservation Covenants

Islands Trust Conservancy will encourage landholders within ecologically significant areas or with significant characteristics or values to protect their land using binding conservation covenants and will work with interested landholders to achieve protection of significant areas.

Islands Trust Conservancy will continue to work with Trust Council to promote and administer the Natural Area Protection Tax Exemption Program (NAPTEP). The program provides a property tax incentive for landholders who register conservation covenants on their lands to protect the natural features and values of their properties.

Islands Trust Conservancy may refuse to acquire properties with existing conservation covenants or other charges on title that include rent charges<sup>6</sup>. Rent charges will not be included in covenants to be registered on Islands Trust Conservancy owned properties as the Conservancy cannot incur liabilities without ministerial approval.

#### Management of Property and Covenants

The acquisition of land or registration of conservation covenants does not by itself guarantee the longterm protection of significant features and values. Active management of protected areas is also necessary. Islands Trust Conservancy's primary objectives in managing its properties are to protect public safety and ecological values. Lands held by Islands Trust Conservancy are not parks but are nature reserves and nature sanctuaries, and this concept is considered in acquisition discussions, management planning, insurance and land use zoning.

To effectively manage ecologically significant areas, Islands Trust Conservancy works cooperatively with First Nations <u>governments and agencies</u>, landholders, contractors, partner conservation groups and other government agencies. Qualified staff, partners and contractors develop management plans for all lands held by Islands Trust Conservancy. Management plans provide long-term direction regarding allowable public use, the reduction of risk to public safety, and the reduction of risk to ecological values and other significant features.

When Islands Trust Conservancy receives donations of land, it consults with the donor(s) regarding any specific wishes they might have for the property and considers these wishes in the management planning process. Generally, management plans will address the following matters:

- · purpose and objectives for the site;
- · background information including the site history;
- First Nations input and engagement\_including naming of nature reserves, as appropriate;
- Ecological inventory;
- management issues such as the extent and nature of protection required, appropriate uses and level of use, research guidelines, risk management, signage, and special needs at the site;
- description of the predicted impacts of climate change and options for mitigation of and adaptation to impacts;
- strategies and actions to achieve the purpose and objectives for the site and to address
  management issues and needs; and
- · use and protection of cultural/archaeological sites.

Management plans are referred for comment to First Nations governments identified through the Contacts for First Nation Consultation Areas mapping tool provided by the Province of British Columbia at https://maps.gov.bc.ca/ess/hm/cadb/. Wherever possible and appropriate, Islands Trust Conservancy works with First Nations governments to appropriately name protected areas and to develop plans for the management of culturally sensitive areas. In most cases, plans showing locations of cultural features or describing cultural feature will be kept confidential or edited to maintain the confidentiality of sensitive information.

Islands Trust Conservancy will seek assistance from partners to implement management plans and, where appropriate, will request partners to enter into contracts with Islands Trust Conservancy regarding management operations and responsibilities.

Islands Trust Conservancy monitors all of its lands and covenanted areas regularly to assess the character and key features of the sites, evaluate the effectiveness of the management program,

identify any new issues that need to be addressed, and identify and respond to any breaches to the terms of a covenant or trespasses on protected lands.

Islands Trust Conservancy will request, where necessary, that local trust committees or island municipalities rezone Nature Reserves and Nature Sanctuaries to the most appropriate designation and zone for nature protection when it is reviewing Official Community Plans and/or Land Use Bylaws and will work with local trust committees or island municipalities to determine the most appropriate designation and zone.

#### Disposition of Property

Islands Trust Conservancy intends to maintain its protected areas in perpetuity. However, there are circumstances where Islands Trust Conservancy will consider transferring property (or interests in a property, such as a conservation covenant) it has acquired to another agency.

Subject to requirements for Consultation with First Nations, if Islands Trust Conservancy receives an unrestricted donation of land with little or no ecological value, and if no other barriers to disposition exist, Islands Trust Conservancy may sell the land and place the proceeds in a fund of Islands Trust Conservancy to be decided by the board.

Subject to requirements for Consultation with First Nations, if Islands Trust Conservancy receives a proposal to transfer an ecologically significant property (or an interest in land) to another conservation agency, and determines that there is no legal barrier to transfer and that the proposal is worthy of consideration, Islands Trust Conservancy will direct staff to conduct and prepare a thorough assessment of the proposal for consideration by the board.

Islands Trust Conservancy will only dispose of a fee simple title or an interest in ecologically significant land if it can be determined that the recipient agency has the expertise and long-term financial resources to manage the property or interest as well as, or better than, Islands Trust Conservancy. If the land, or interest in land, was acquired as an Ecological Gift, Islands Trust Conservancy will notify Environment and Climate Change Canada of the disposition.

Islands Trust Conservancy will consider the following tools to ensure that any transferred land and associated values will be protected in perpetuity for the residents of the Trust Area and the people of British Columbia:

- a) Islands Trust Conservancy may transfer land on condition that it be used for conservation purposes, or transfer land as determinable fee simple providing that the land will revert to Islands Trust Conservancy if the land is no longer being used for the specified purposes.
- b) Islands Trust Conservancy may register a conservation covenant on title to land before a transfer, to ensure the protection of the land's ecological values, provided an appropriate agency can be found to hold the covenant, and the recipient agency has the legal authority to accept the encumbrance.

## Section 3: Communication, Cooperation and Liaison

#### Communication

Islands Trust Conservancy board members and staff conduct activities in a manner that enhances Islands Trust Conservancy's reputation as an organization that works proactively, constructively and collaboratively to advance Islands Trust Conservancy Three-Year Plan.

Islands Trust Conservancy's land conservation negotiations are confidential and will be treated as such by all board members and staff of Islands Trust Conservancy. Generally, information about on-going covenant and land donation projects will not be discussed or announced publicly until the project is complete, unless the project is associated with a development application, or the applicant has specified that the project may be discussed publically. <u>To meet its commitments</u> under its Reconciliation Declaration, Islands Trust Conservancy may elect to refer conservation proposals to First Nations. Where referral is desired or required, staff will inform applicants and partners that details of the conservation proposal will be shared with First Nations.

#### Collaboration

Islands Trust Conservancy works collaboratively with other agencies, First Nations and individuals to promote conservation in the Islands Trust Area. Staff and Board members participate regularly in partnerships with various levels of government, non-profit organizations, community groups and other agencies to further preservation of nature in the Islands Trust Area. Islands Trust Conservancy wishes to maintain good communications with First Nations and other agencies working in the region. The approach to First Nations engagement will be consistent with Islands Trust First Nations Engagement Principles Policy 6.1.1.

#### Advocacy

Islands Trust Conservancy will ensure that its advocacy positions are consistent with Islands Trust Conservancy Three-Year Plan and Islands Trust Advocacy Policy 6.10.3 and are supported by a resolution of the board. Advocacy letters from Islands Trust Conservancy to elected officials will be signed by a board member.

# 6. CONCLUSION

Guided by the Regional Conservation Plan, Islands Trust Conservancy will continue to pursue its mandate in accordance with its policies and in partnership with individuals, island communities and First Nations governments and agencies, as well as local, regional, provincial and national conservation and government agencies.

Islands Trust Conservancy will continue to strive for organizational excellence, and to eliminate barriers to its continued success. With excellent working relationships with the island- based and regional land trusts and strong connections to local and regional governments, Islands Trust Conservancy is well positioned to take a lead role in the protection of the ecologically significant areas found in Canada's islands in the Salish Sea.

With a focus on building relationships with First Nations governments and agencies over the next three years, Islands Trust Conservancy will ground its conservation actions firmly in respectful relationships with First Nations and Indigenous Peoples. Islands Trust Conservancy looks forward to the next three years of conservation successes, inspired by the generosity and perseverance of our partners, collaborators and supporters, and the endless beauty of fragile island ecosystems.

## SUBJECT: Galiano Local Trust Bylaw 231/232 Referral – Nature Protection Rezoning

**RECOMMENDATION(S):** That the Islands Trust Conservancy (ITC) Board recommend that the Galiano Island Local Trust Committee approve Bylaws 231 and 232 because they bring zoning into agreement with the use of conservation lands and further strengthen the conservation status for District Lots 64 and 68, which are adjacent to Islands Trust Conservancy covenanted areas.

**1 PURPOSE:** To review the referral of Galiano Island Local Trust Committee (Galiano LTC) Bylaw 231 and 232 and to provide a response from the Islands Trust Conservancy (ITC) Board to the Galiano LTC.

### 2 BACKGROUND:

As noted in the referral form, the proposed amendments to the Galiano Island Official Community Plan Bylaw No. 108 (OCP) and Land Use Bylaw No. 127 (LUB) are intended "to re-designate and rezone portions of District Lots 68, 72 and all of DL 87 parcels from a Forestry designation and Forest 1 (F1) zoning to Nature Protection and District Lot 64 from a Rural designation and Rural 2 (R2) zoning to Nature Protection."

ITC has received this referral because DL 68 and DL 64 are adjacent to two ITC conservation covenants – Laughlin Lake covenant and Cable Bay covenant, respectively (Figure 1). Staff have reviewed the bylaws for impacts to ITC managed lands and find them to be compatible with the preservation of conservation values on those lands. The proposed Nature Protection zoning allows the following:

#### 11. NATURE PROTECTION ZONES

#### 11.1 Nature Protection Zone - NP

Permitted Uses

- 11.1.1 In the Nature Protection zone the following uses are permitted, subject to the regulations set out in this section and the general regulations set out in Parts 2 and 3, and all other uses are prohibited.
  - 11.1.1.1 ecological reserves and nature conservancies
  - 11.1.1.2 research and educational activities
  - 11.1.1.3 groundwater retention and recharge
  - 11.1.1.4 ecological restoration
  - 11.1.1.5 passive recreation

**Buildings and Structures** 

11.1.2 No buildings or structures of any kind, other than signs, are permitted.

### 1 PURPOSE:

## 2 BACKGROUND:

#### Meeting Dates

Near the end of each calendar year, the ITC Board determines the meeting dates for the next calendar year by way of resolution. The ITC Meeting Procedure Bylaw states that six meetings should be held each year spread evenly through the calendar year, and that the first meeting of the year shall be held in January or February. *It was MOVED and SECONDED,* that Financial Planning Committee recommend that ITC, FPC, TPC and RPC hold all but one meeting electronically annually and the budget be amended accordingly.

#### **3** IMPLICATIONS OF RECOMMENDATION

**ORGANIZATIONAL:** Staff support is required to coordinate and administer electronic meetings and to post recordings of meetings online and to coordinate the one in-person meeting.

**FINANCIAL:** The ITC's proposed 2023/24 budget anticipates that all meetings except one will be remote. An increase to in-person meetings would result in an impact to the ITC budget request provided to Trust Council

POLICY: None.

**IMPLEMENTATION/COMMUNICATIONS:** Approved meeting schedule will be posted to the Islands Trust website and added to relevant electronic calendars.

**FIRST NATIONS:** Holding meetings electronically and posting meeting recordings to the website may provide greater transparency and access to First Nations.
