1. CALL TO ORDER

Chair Elliot called the meeting to order at 11:02 am. She acknowledged that the meeting was being held in territory of the Coast Salish First Nations. She introduced herself, Trustees, Staff, and Director Fall and welcomed members of the public.

2. APPROVAL OF AGENDA

By general consent the agenda was approved as presented.

3. RISE AND REPORT - None

4. **REPORTS**

4.1 Trustee Reports

Trustee Peterson spoke on the following:

- Welcome to the new Local Trust Committee.
- Chairing recent meetings on Hornby, Salt Spring and Galiano Island.
- Recently elected by Trust Council to the new Governance Committee.
- Continuation as a member of the Trust Programs Committee and the Financial Planning Committee.
- Notable Issues for consideration this term are: reinstating a second Town Hall
 opportunity for the public; accommodation of persons with disabilities; amending
 the Land Use Bylaw regarding the 4 Hectare subdivision size loophole; potential
 amendment for the Strategy for Antennae Systems focusing on First Nations
 consultation; completion of the Official Community Plan review is contingent on
 First Nations consultation which is contingent on the Islands Trust position of Senior

Intergovernmental Policy Advisor being filled soon; future consultation with the Islands Trust Senior Freshwater Specialist.

Trustee Lironi spoke on the following:

- Attending Trust meetings and learning as a new Trustee.
- Becoming a member of the Regional Planning Committee.
- Meeting with Snaw-naw-as First Nation and learning about their perspective of Lasqueti Island.

4.2 Chair's Report

Chair Elliot spoke on the following:

- Experience as a Trustee on Gabriola Island working on the Official Community Plan (OCP) Review
- Excited to be the new Chair for Lasqueti Island as its Official Community Plan (OCP) review moves forward.
- As a member of the board of the Islands Trust Conservancy, can inform on their reports and provide information on First Nations consultation for stream management strategies.
- As a member of the Regional Planning Committee, looking forward to working with the Northern Gulf Islands and the Province for appropriate rural housing strategies.
- Welcoming members of the community to email their questions or concerns.
- Consider that Reconciliation is very important work.

4.3 Electoral Area Director's Report

Director Fall spoke on the following:

- qathet Regional District (qRD) budget discussions.
- It is the goal of qRD to meet annually with local Trustees to talk about subject areas of jurisdictional overlap. A meeting is anticipated sometime in the new year.
- qRD Coastal Shoreline Flood Risk Mapping Project data could be useful for Lasqueti land use planning to identify local shoreline areas at risk of erosion. There are some sensitivity concerns for property owners' shorelines identified as being in a red zone.
- An upcoming qRD report on options for affordable housing in rural areas.

5. TOWN HALL

Members of the public spoke on the following:

- Poor landline service by Telus is dangerous for residents with health conditions or unexpected injuries. Telus is intentionally squeezing Lasqueti so that they don't have to service the system. Can qRD or Islands Trust put some pressure on Telus to properly service the island?
- Telus treats individual resident outages differently than multi resident outages. It is the CRTC's, not Telus,' obligation to ensure phone service; and the rules are different when there are multiple providers. A new letter from the Local Trust Committee (LTC) to Telus would be helpful; the right part of the Telecommunications Act should be referred to in any letter to Telus; and a future letter could be cc'd to the Member of Parliament who may have advice.

- Lasqueti Island is a lost leader for Telus.
- Lasqueti does not have a Development Permit Area (DPA), and there is popular revolt against any mention of DPAs. Hopefully, Trustees will resist any attempt to institute DPAs on Lasqueti Island.
- An expected pending Administrative Bylaw referred to in the agenda on Page 14: -Adoption of a Land Use Permit Delegation Bylaw: this bylaw would delegate the approval of development permits to staff for all DPAs except Form and Character- seems disingenuous when Lasqueti does not have a DPA and it is giving more decision-making power to staff over Trustees. Lasqueti Islanders would prefer that local elected representatives make decisions for the island, not unelected bureaucrats.
- The OCP review has stalled, the agenda shows \$5000.00 allocated that was never used because the local First Nation had requested by letter that it be paused for review. It then took 7 months for staff to respond, which is insulting to the First Nation. The Trust Executive should take note of this.
- Future large subdivisions can be given extra lots because of the 4 hectares coming out to less than 10 acres. The LTC should attend to this.
- There should be a second Town Hall session at the end of the LTC meeting which encourages people to stay for the whole meeting and comment on the proceedings.
- The Islands Trust has a duty to accommodate persons with disabilities at their meetings, including the hearing impaired who could be accommodated by giving microphones to the speakers.
- What is this Chair's view on attendants' recording LTC meetings for their own personal use and could the Chair consult with the Islands Trust legal department?
 - The Chair responded that it was a courtesy to ask first because some members of the public may not want to be recorded. The Chair offered to consider the question further.

6. MINUTES

6.1 Local Trust Committee Minutes – None

The LTC regular and in-camera minutes dated August 29, 2022 were adopted by Resolution Without Meeting in October and November of 2022.

6.2 Section 26 Resolutions-Without-Meeting Report dated January 13, 2023

Trustee Peterson noted that the minutes of the last LTC meeting of August 29, 2022 were adopted by resolution without meeting because the scheduled November 28, 2022 meeting was canceled due to the coinciding election and election of a new Trustee who would have had no historical context with which to review the old minutes.

6.3 Advisory Planning Commission Minutes – None

Trustee Peterson noted that the Advisory Planning Commission (APC) had attempted to meet in June 2022; had failed to reach quorum; then the term ended, and only one application had been received by the LTC by August.

7. BUSINESS ARISING FROM MINUTES

7.1 Follow-Up Action List dated January 13, 2023

The following issues regarding the Follow-up Action List were discussed:

- The regrettable 7-month delay in staff responding to Snaw-naw-as First Nation was discussed and noted.
- That Trust Area Services will be taking the lead in drafting letters for outreach to First Nations going forward.
- That the Trust is considering the hiring of an Administrative Coordinator to track communications so that they are not duplicated or left undone.
- That the Senior Intergovernmental Policy Advisor position was on the verge of being filled, so outreach to Snaw-naw-as was better deferred to next meeting.
- The Follow-Up Action List has changed to a new system. Instead of a 3 item Top Priorities List and a Projects List, the LTC will have 1 Major and 1 Minor Project ongoing.
- The Community to Community (C2C) funding grant to establish relationship with First Nations has 3 intakes per year, but only one LTC per year can receive one.
- A late letter received by the LTC by a resident who had not received any notification for today's meeting.
- The present meeting was on schedule and the public notified; it was uncertain what further measures could have been taken to enhance public notification.
- The current standing resolution on meeting procedures had added a protocol for public notification of a late change in time, date, or place for a scheduled LTC meeting, thereby filling a gap in the meetings procedures bylaw.

9. LOCAL TRUST COMMITTEE PROJECTS

9.1 Review of Active and Future Projects - Staff Report

Planner Zupanec presented the staff report which asks Trustees to review their Work Program of active and future LTC projects and provide direction to Staff of their priorities.

Planner Zupanec noted that LTCs were permitted 1 Major Project and 1 Minor Project in a fiscal year. Potential future Major Projects are ones with an expected budget over \$5000.00 in a fiscal year and would require a planner and a Business Case to be initiated in spring to allow time for final Trust approval in December.

A Trustee noted the following:

- The expected cost to continue the OCP Review this fiscal year was under the \$5000.00 threshold and so a business case had not been applied for it.
- There are two referrals outstanding to the Advisory Planning Commission (APC): one regarding the definition of 'Community Benefit,' as it applies to Temporary Use Permits (TUPs); and one regarding the objections of the Ministry of Forest, Lands, Natural Resource Operations and Rural Development (FLNRORD) to proposed OCP advocacy policies for Crown Land. Snaw-naw-as First Nation is also concerned that certain policies may fetter their Woodlot License. The LTC needs to know the specifics of Snaw-naw-as objections.

LA-LTC-2023-002

It was MOVED and SECONDED,

that the Lasqueti Island Local Trust Committee request that staff prepare a referral to the Advisory Planning Commission to either define 'Community Benefit' for the Official Community Plan Project as it relates to Temporary Use Permits or recommend a process by which the Local Trust Committee could define 'Community Benefit.'

CARRIED

The meeting was recessed at 12:31 pm due to electrical disconnection and reconvened at 12:37 pm.

A Trustee noted that a subdivision regulation amendment to increase minimum lot size at time of subdivision from 4 Hectares to 4.04 Hectares in the Land Use Bylaw (LUB) to align with a 10-acre minimum lot size will close a loophole that allows extra lots to be derived from large subdivisions. The Lasqueti community has always had a felt expectation for the 10-acre minimum lot size.

Planner Zupanec noted the following:

- Currently, the OCP metrics are consistent with the Land Use Bylaw (LUB) metrics, and both bylaws would need to be amended.
- New subdivision applications would be grandfathered into existing regulations until the amendment had fully passed.
- The OCP/LUB metric amendments could be done as a minor project for 2023 beginning with work on a Project Charter which needs no funding. Funds for public engagement would not be needed until fiscal 2024. The entire project might take a minimum of a year, after which Ministry approval may take up to 8 months.
- Given that the ongoing OCP review project is a minor project rather than a major one, there would not be funds for 2 minor projects in a fiscal year, because only 1 major and 1 minor project can be funded at a time.
- Minor projects are done in-house with existing staff; major projects go to the Regional Planning Team for pre-approval.

By general consent, the meeting recessed at 1:01 pm and reconvened at 1:35 pm.

Planner Zupanec noted that the Cultural Heritage Protection Implementation is completed at Regional Planning and it is up to the LTC to determine if it has local relevance.

Chair Elliot noted that the Cultural Heritage Overlay Mapping Program had been halted with the loss of the consultant and some First Nations concern with the process.

I just wanted to draw attention to the following, as i think it may be appropriate to advance to other LTC's for discussion, and possible adoption or inclusion into their protocols.

In particular, for the Northern region, I would like to see this on both the Hornby and Lasqueti agendas as soon as practical.

"FYI In regard to the tower siting protocol, SSI passed a new standing resolution to address FN consultation:

That the Salt Spring Island Local Trust Committee adopt the following standing resolution with respect to

First Nations consultation in accordance with the "Strategy for Antenna Systems" in the Local Trust Area:

a. The proponent will consult with the Local Trust Area representative during the preconsultation

phase to determine proximity of the proposed antenna system to known archaeological sites and/or areas of archaeological potential and obtain a list of First Nations rights and title holders;

b. The proponent is recommended to undertake consultation during the pre-consultation phase with the Islands Trust and a First Nations cultural knowledge holder for the siting of the proposed

antenna system as it relates to cultural and sacred sites;

c. The proponent will obtain and provide a BC Archaeological Information request response from

the BC Archaeology Branch to confirm proximity of the proposed antenna system to known archaeological sites and/or areas of archaeological potential including permit requirements under

the Heritage Conservation Act;

d. The proponent will obtain and provide an Archeological Impact Assessment for antenna systems

proposed to be sited on or within 100 metres of a known archaeological site or cultural/sacred site identified by a First Nations cultural knowledge holder; and

e. The proponent will provide written notice – including, if applicable, the Archeological Impact Assessment – sent by regular mail or hand delivered to all First Nations rights and title holders identified during the pre-consultation phase:

RECOMMENDATION

1. That Lasqueti Island Local Trust Committee approve the updated Lasqueti Official Community Plan Project Charter version 4.5, dated March 2023.

REPORT SUMMARY

This report summarizes minor updates to the April 2020 <u>version 4.4 of the Official Community Plan (OCP) Project</u> <u>Charter</u> in order to expand the scope of project activities based on Local Trust Committee (LTC) discussion at the January 2023 meeting, and highlight those elements of the project that have been completed or are still pending action. The project charter is intended to be updated regularly to accurately reflect the project work plan progress and deliverables for Proposed Bylaw No. 98 as it moves through the legislative review process.

BACKGROUND

At the January 2023 regular business meeting, the LTC passed the following resolutions:

LA-LTC-2023-003 It was MOVED and SECONDED,

that the Lasqueti Island Local Trust Committee request staff to prepare a status update report on the 1st Reading draft format of the Official Community Plan Review Project and provide a preliminary analysis of Land Use Bylaw alignment with it. <u>CARRIED</u>

A status update report is currently being prepared by staff for consideration by the LTC at the next LTC meeting date.

LA-LTC-2023-004 It was MOVED and SECONDED,

that the Lasqueti Island Local Trust Committee amend the Official Community Plan Review Project Charter by including consideration of adjusting references to minimum lot size at subdivision and Lasqueti Land Use Bylaw No. 78 Section 3.11 subdivision regulations, and to increase the number to reflect a 10-acre minimum lot size. <u>CARRIED</u>

Attachment #1 reflects the LTC endorsed amendment. Staff have highlighted all sections of the project charter and workplan that will require updates in the near future to reflect intended next steps, dependant on budget confirmation and desired direction of the LTC following review of the status update report.

Rationale for Recommendation

The project charter has been updated to include the LTC requested in-scope activity to amend all OCP and LUB references to minimum lot sizes at subdivision to 10 acres (4.04 ha). Staff have also identified areas of the project charter that will need to be updated once a workplan for the 2023-2024 fiscal year has been determined (pending Trust Council budget approval) and the LTC has discussed options for next steps at a future LTC meeting date.

ALTERNATIVES

1. Further amend the Project Charter

The LTC can further amend the Project Charter at this time with any level of detail necessary to more accurately reflect the next steps in the legislative review process during the 2023-2024 fiscal year. If selecting this alternative, the LTC should describe the specific amendments. Recommended wording for the resolution is as follows:

That the Lasqueti Island Local Trust Committee amend the draft Official Community Plan Project Charter version 4.5, dated March 2023 with the following changes (specify changes).

NEXT STEPS

Once the project charter has been endorsed by the LTC, staff will update the <u>project website</u> and finalize a comprehensive staff report for future LTC consideration, providing a review of Proposed Bylaw No. 98; anticipated next steps in the workplan and potential Land Use Bylaw amendments required to enact the OCP policies, if adopted.

Purpose: To review and update the Lasqueti Official Community Plan (OCP) policies and Land Use Bylaw (LUB) regulations in three phases which supports community participation, the Object of the Islands Trust, strengthens relations with First Nations and addresses community land use planning priorities.

Background: The LTC identified a "Comprehensive OCP/LUB Review" as a top priority project and held an early community information meeting in April 2018 to gather ideas on the scope of the project. Support for the Islands Trust's "preserve and protect mandate", including a focus on strengthening relations with Tla'amin Nation and other Nations, are overarching priorities for this review.

Objectives

- Conduct a technical analysis of the OCP and LUB:
- incorporate the results of 2018 engagement sessions held by the Lasqueti Community Association;
- determine where policy/regulatory changes may be required to be consistent with First Nations relations and perspectives; the Local Government Act, and Object of the Islands Trust and Islands Trust Policy Statement; Islands Trust **Conservancy 'Regional** Conservation Plan 2018-2027' goals and priorities, Protection of the Coastal Douglas-fir and Associated Ecosystems Toolkit (2018); and
- Develop an 'OCP/LUB Engagement Strategy' to prioritize engagement topics and methodology to be undertaken in Phase 2; and
- Update subdivision regulations related to proof of water and public access to the foreshore.

Phase 2, 3 and 4 **Objectives**

- Undertake community engagement on engagement topics determined in Phase 1.
- Develop, review, adopt draft amending bylaws to update the OCP and LUB based on Phase 1 analysis and Phase 2 community engagement.

- Establish opportunities for inter-governmental collaboration for effective decision making respecting Treaty and First Nations rights throughout both phases of the OCP/LUB review. PENDING

- Legislative review, referrals and bylaw adoption of OCP updates **PENDING**

- Update subdivision regulations related to proof of water and public access to the foreshore.
- Update OCP and LUB with updated references to minimum lot sizes at subdivision to be 10 acres (4.04 ha).

DIRECTOR OF PLANNING SERVICES COMMENTS: The draft Freedom of Information and Protection of Privacy bylaw is in line with current legislation and Schedule of Fees.

1 **PURPOSE:**

To adopt the new Freedom of Information and Protection of Privacy bylaw and model bylaw to bring them in line with updated legislation.

2 BACKGROUND:

On November 25, 2021, the Government of British Columbia enacted Bill 22 bringing into force significant amendments to the *Freedom of Information and Protection of Privacy Act*. The *Act* governs how public bodies collect, use and disclose the personal information of individuals.

The current local trust committee freedom of information and protection of privacy bylaws have been unchanged since they were adopted in 1994. Since that time, amendments have been made to the *Act*, as well as fees updated.

At its regular business meeting June 21 to 23, 2022, Trust Council adopted a model Freedom of Information and Protection of Privacy Bylaw, and passed the following resolution:

That Trust Council request all local trust committees to consider adoption of a new Freedom of Information and Protection of Privacy bylaw based on the model bylaw.

Staff has drafted a new Freedom of information and Protection of Privacy Bylaw for each Island Local Trust Committee based on the adopted model bylaw.

3 IMPLICATIONS OF RECOMMENDATION

ORGANIZATIONAL:

Minimal staff time to update material on the website.

FINANCIAL:

Fees incurred can be charged current amounts for actual costs and reflect charges for various media formats, including digital records.

POLICY: N/A

Staff would update the Islands Trust website with the new bylaws.

There is no impact on First Nations on the adoption of the new Freedom of Information and Protection of Privacy bylaw and model bylaw.

LASQUETI ISLAND LOCAL TRUST COMMITTEE FREEDOM OF INFORMATION AND PROTECTION OF PRIVACY BYLAW NO. 101

A Bylaw to designate the head of the Lasqueti Island Local Trust Committee for the purposes of, and to set fees under, the *Freedom of Information and Protection of Privacy Act*, RSBC 1996, c. 165, as amended.

GIVEN THAT:

- A. Section 77(a) of the *Freedom of Information and Protection of Privacy Act*, RSBC 1996, c. 165, as amended (the "Act"), gives the Lasqueti Island Local Trust Committee the authority to designate a person as the head of the Lasqueti Island Local Trust Committee for the purposes of the Act, and
- B. Section 77(c) of the Act gives the Lasqueti Island Local Trust Committee the authority to set any fees the Lasqueti Island Local Trust Committee requires to be paid under section 75 of the Act,

THE LASQUETI ISLAND LOCAL TRUST COMMITTEE ENACTS AS FOLLOWS:

Citation

1. This bylaw may be cited as "Lasqueti Island Local Trust Committee Freedom of Information and Protection of Privacy Bylaw No. 101, 2023".

Definitions and Interpretation

2. In this Bylaw:

"Act"	means the <i>Freedom of Information and Protection of Privacy Act</i> , RSBC 1996, Chapter 165, as amended.
"Commercial Applicant"	means a person who makes a request for access to a record to obtain information for use in connection with a trade, business, profession or other venture for profit.
"Head"	means the person designated under Section 3 of this Bylaw as the head of the of the Lasqueti Island Trust Committee for the purposes of the Act.
"Request"	means a request for information under Section 5 of the Act.
"Records"	includes books, documents, maps, drawings, photographs, letters, vouchers, papers and any other thing on which information is recorded or stored by graphic, electronic, mechanical or other means, but does not include a computer program or any other mechanism that produces records.

Designation of Head

- 3. The person from time to time appointed to the position of Secretary of the Islands Trust is designated as the Head of the Lasqueti Island Local Trust Committee for the purposes of the Act.
- 4. The person from time to time appointed to the position of Deputy Secretary of the Islands Trust and the person from time to time appointed to the position of Deputy Treasurer of the Islands Trust, each are authorized to perform any duty or exercise any function of the Head who is designated under Section 3.

Policies and Procedures

5. The Heads authorized to perform the duties of the Head shall operate in accordance with the Act and the Freedom of Information and Protection of Privacy policies, guidelines, and procedures, as set by the Islands Trust Council from time to time.

Fees

6. The fees that are payable by applicants under the Act are those set out in Schedule A to this bylaw.

Interpretation

7. Any word or expression used in this bylaw that is not defined in this bylaw has the meaning given to it in the Act on the date of final adoption of this bylaw.

Repeal

8. "Lasqueti Island Trust Committee Freedom of Information and Protection of Privacy Bylaw No. 49, 1994", is hereby repealed and replaced by this bylaw.



HIGHLIGHTS OF ISLANDS TRUST CONSERVANCY January 24, 2023 BOARD MEETING

1. ORGANIZATION UPDATES/TEAM

- Nominations for the Chair, Vice-Chair and Financial Planning Committee (FPC) representative were held. Trustee Adams was elected Chair of ITC Board, Trustee Smith was elected Vice-Chair, and Trustee Yates was elected as the FPC representative.
- The ITC Board discussed the ITC ex officio seat on the Governance Committee, noting the ITC Chair will appoint a member to the committee. Shortly after the ITC meeting, the ITC Chair appointed Trustee Grant Scott as the ITC Board's ex-officio member on the Islands Trust Council's Governance Committee.
- The ITC Board continues to have a vacancy for one Ministerial appointment. The posting for the vacancy closed on October 7, 2022. The ITC Board is awaiting news from the <u>Crown Agencies</u> and <u>Board Resourcing Office</u> regarding a potential new member.

2. STRATEGIC PLANNING/ADMINISTRATION

- The ITC Board approved the draft 2023-2025 Islands Trust Conservancy Interim Plan in November 2022 and directed staff to forward it to the Minister of Municipal Affairs by December 31, 2022, for review and approval. A meeting has been set to discuss the plan with Ministry staff. Staff will inform the ITC Board of the outcomes.
- The ITC Board reviewed and approved the 2026-2030 ITC Plan Project Charter.
- The ITC Board reviewed and approved the 2023-2026 Species at Risk Program Project Charter.
- The ITC Board reviewed the 2023/24 ITC Budget briefing from the Financial Planning Committee. The ITC Board discussed potential budget reductions and moved that ITC Budget has been carefully considered potential budget reductions and their implications, and concluded that its budget request is necessary and responsible going forward.

3. COVENANT AND PROPERTY ACQUISITIONS

- The ITC Board received reports on covenants and acquisitions for information.
- ITC registered a 11.35 hectare covenant, known as the Livingstone Covenant on Lasqueti island. This covenant is the first covenant on Lasqueti and is part of the Natural Area Protection Tax Exemption (NAPTEP) Program. It was gifted through the Federal Ecological Gifts Program.

- The ITC Board awarded a \$4,614.75 grant from the Morrison Waxler Biodiversity Legacy Fund Grant program to expand the existing Nighthawk Hill NAPTEP covenant on North Pender Island.
