

## Re: Welcome and meeting request

I am writing on behalf of the Islands Trust Council to congratulate you on your appointment as Chair of the Agricultural Land Commission (ALC). I know that you have some familiarity with the Islands Trust but I am writing to provide you with background on the Islands Trust and its relationship with the ALC, and to request a meeting with you.



The Islands Trust is a unique federation of local government bodies with a provincial mandate from the *Islands Trust Act* to make land use decisions that will "preserve and protect" British Columbia's southern coastal islands. The Trust Area covers the islands and waters between the mainland and southern Vancouver Island, including Howe Sound and as far north as Comox. The Trust Area is a unique and special place composed of 13 major islands and more than 450 smaller islands, with an exceptional variety of species of birds, fish, wildlife and vegetation. The Islands Trust Area map to the left shows you the largest islands we are responsible for.

In 1974, the provincial government formally recognized the Islands Trust Area as an area of provincial significance, which required special protection from development pressures. The *Islands Trust Act* established the Islands Trust as a unique land use planning agency, acting for both the residents of the Trust Area and the province generally, and having a special conservation-oriented responsibility. The *Islands Trust Act* directs that we preserve and protect the area in cooperation with others.

Each island in the Trust Area possesses its own unique history of food production and harvesting. There is a rich history of First Nations food production, while one hundred and fifty year old homesteads and farms indicate that food production was, and continues to be, an important way of settler life and source of island culture.

In the early to mid- twentieth century, parts of the Trust Area served as net exporters of produce to Vancouver Island and the lower mainland. While volumes have deceased, many islands continue to have vibrant farming communities, demonstrated by the number of farmer's institutes, agricultural halls, thriving farmer's markets and harvest festivals. With the resurgence of interest in local food systems, these community-scale, agricultural successes are once again leading the way as sources of important local knowledge and information sharing. In comparison to other places in British Columbia, Islands Trust Area farms are often smaller and more commonly use organic, labour-intensive farming approaches.

You may also be interested to know that the Denman Island and Salt Spring Island Local Trust Committees have adopted Area Farm Plans for their islands, and actively support the implementation of these plans by agricultural partners in the community.

A key element of the mandate of the Islands Trust Council is working with other governments and agencies to protect our unique islands. Protecting farm land and enhancing sustainable agricultural activity is a fundamental component of healthy island communities. The Islands Trust and the Agricultural Land Commission's relationship is underpinned by our <a href="Protocol Agreement on Agricultural Land Reserve">Protocol Agreement on Agricultural Land Reserve</a> in the <a href="Trust Area">Trust Area</a> and our <a href="Letter of Understanding on Agricultural Land Reserve">Land Reserve</a> in the <a href="Trust Area">Trust Area</a>.

The Islands Trust Council remains concerned about the ongoing health of the agricultural sector and the potential long-term impacts on land-use patterns within the Islands Trust Area. Thirteen and a half per cent of the Islands Trust Area land base is within the ALR. Thirty-seven per cent of the ALR in the Trust Area is forested and 19 per cent of the Islands Trust Area's sensitive ecosystems are within the ALR.

In keeping with the spirit of our original agreements and our shared interests in the well-being of island communities, the Islands Trust Council invites you to meet with us during our quarterly business meeting on Wednesday, June 20 on Saturna Island, between 10:00 a.m. – 3:00 p.m.

Thank you for considering this request. I look forward to hearing from you.

## Re: Agricultural Land Reserve and Agricultural Land Commission Revitalization

Thank you for the opportunity to comment on the revitalization of the Agricultural Land Reserve (ALR) and Agricultural Land Commission (ALC). The Agricultural Land Reserve is an important asset in the Islands Trust Area. By supporting food security and protecting farming opportunities for current and future farming families, the ALR helps sustain the character of our islands and the health of our communities.

The Islands Trust Council supports the preservation of the ALR and its management by an independent and adequately funded ALC. Under the *Islands Trust Act* 

The object of the Trust is to preserve and protect the Trust Area and its unique amenities and environment for the benefit of the residents of the Trust Area and of British Columbia generally, in cooperation with municipalities, regional districts, improvement districts, other persons and organizations and the government of British Columbia.

The ALR forms part of the unique amenities of the Trust Area and both the ALC and the Islands Trust share a responsibility for the protection of farmland and farming activities on the islands. Thirteen and a half per cent of the Islands Trust Area land base is within the ALR, and 37 per cent of the ALR in the Trust Area is forested.

Lands within the ALR in the Islands Trust Area face intense development pressures. The ALC should be mandated and funded to conduct thorough permit application reviews and timely enforcement of infractions. We would also like to see the ALC reinvigorate proactive work such as:

- regional-level land use planning;
- analysis of permitted uses; and
- the preservation and encouragement of agricultural farm uses.

Compared with many farms in British Columbia, the farms in the Islands Trust Area may challenge conventional notions of what 'agriculture' is, what normal farm practices are, and what viable farming operations can look like. The ALC should therefore have the ability to be responsive to the sometimes unique situations of our islands. In brief, the Islands Trust Council holds that agricultural policies applied to the Trust Area should be appropriate to the nature of agriculture practices within the Trust Area. We would like you to be aware that, although we do not have a policy position on this matter, we are hearing concerns about the potential impacts of cannabis production facilities on Agricultural Reserve Land.

The Islands Trust Council encourages agricultural management practices that are compatible with sustaining wildlife habitat. Notably, 19 per cent of the Islands Trust Area's sensitive ecosystems are within the ALR. Trust Council has policy direction that the natural wetlands of the Trust Area, including those in the ALR that have not been altered in the past for agriculture, should not be drained, filled, or degraded.

As you consider the actions required to revitalize the ALR and the ALC, we request that you also consider the need for quality information about the changing state of agriculture. After 2006, Statistics Canada changed the way in which it manages the Census of Agriculture data and is no longer able to provide information by custom geographic areas. Our inability to access island specific or Trust Area specific information hampers our ability to assess the changes and needs of agriculture on our islands. We would also benefit from greater knowledge about the role that the ALC and ALR can play in reducing barriers to First Nations food gathering and food sovereignty.

The Islands Trust Council looks forward to collaborating proactively with the ALC to preserve and protect agricultural land in the Trust Area. We hope to meet with the ALC at our June Council meeting on Saturna Island to discuss issues of importance in our region. We are hopeful there may be discussion at that time about:

- policies to sustain and encourage small farms in the islands;
- farm worker housing issues;
- enforcement of infractions; and
- a possible review of the ALR boundaries within the Islands Trust Area to assess whether farmed areas currently outside the ALR should be added to the ALR.

On that last point, Trust Council has a policy position that encourages the ALC to approve applications from property owners for inclusion of land with potential for agriculture into the ALR.

Thank you for considering this input. The Islands Trust Council is a federation of local government bodies representing 26,000 people living within the Islands Trust Area and about 10,000 non-resident property owners. The Islands Trust Council establishes overall policy direction for the Islands Trust, and has a protocol agreement and letter of understanding with the ALC. Local trust committees and Bowen Island Municipality contribute to the protection of agricultural lands in the Islands Trust Area in three key ways: through land use designations; through the development of community land use plans and regulatory bylaws that support sustainable agriculture, minimize adverse effects and protect soils; and through participation in food and agricultural studies.

The Islands Trust is responsible for preserving and protecting the unique environment and amenities of the Islands Trust Area through planning and regulating land use, development management, education, cooperation with other agencies, and land conservation. The area covers the islands and waters between the British Columbia mainland and southern Vancouver Island. It includes 13 major and more than 450 smaller islands covering 5200 square kilometres.

We appreciate your consideration of this input. There are many First Nations who have asserted Aboriginal interests in the Trust Area and many who have established harvesting rights. Although we copy First Nations on all correspondence such as this, we have not directly heard their positions on the Agriculture Land Reserve. Given our commitment to establishing and maintaining a mutually respectful relationship with First Nations, we offer the Islands Trust position while being ready to respectfully consider their positions.

You will also be hearing from the Trust Fund Board, a separate statutory body within the Islands Trust.
