11. TRUSTEE REPORTS

Trustee Grove reported he is planning to attend the Financial Planning Committee meeting in Victoria on January 22, 2019. Trustee Grove acknowledged Trustee Patrick for bringing forward the idea to form a Salt Spring Housing Working Group, noted the Islands Trust toolkit is limited

to land use planning and spoke to the Capital Regional District's role in providing affordable housing.

Trustee Patrick reported she attended meetings with the following: the Salt Spring Island Watershed Protection Alliance (SSIWPA); Joe Akerman regarding Xwaaqw'um Village wetland restoration and the Islands Trust reconciliation work; the Climate Action Plan Steering Committee; the Area Farm Plan Steering Committee; and the SSI Rotary Club regarding island businesses and workforce housing. Following the meeting with the SSI Rotary Club, Trustee Patrick toured the local business Symmetric Designs Ltd. Trustee Patrick reported she met with Capital Regional District (CRD) Director Holman and University of Victoria Professor Tom Gleeson to discuss an upcoming hydrogeological project investigating the permeability of the geological fault zone in Fulford Harbour and noted the study will be closely monitored by SSIWPA's Technical Working Group. She reported SSIWPA has elected Trustee Patrick as Chair and CRD Director Holman as Vice Chair and noted SSIWPA's rainwater harvesting materials should be available this Spring; and that the Salt Spring Community Alliance is planning to host a Spring 2020 Meeting regarding water, which SSIWPA will assist with. Trustee Patrick attended Member of Parliament (MP) Elizabeth May's Community Town Hall event on January 17, 2020 and in advance of the meeting Trustee Patrick spoke to CBC Radio All Points West show on the topic of floating homes. Trustee Patrick reported Member of the Legislative Assembly (MLA) Adam Olsen is planning to organize a meeting with stakeholders regarding float homes and noted the Trust Council's Executive Committee has selected the topic of seeking a regional approach to liveaboards to develop into a resolution for the Association of Vancouver Island and Coastal Communities and hopefully onto the Union of BC Municipalities. Trustee Patrick is planning to attend the Our Forests: A Community Conversation meeting hosted by the Salt Spring Community Alliance on January 27, 2020 at 7:00 p.m. and will attend the North Pender Island Local Trust Committee and South Pender Island Local Trust Committee meetings next week. Trustee Patrick reported the Area Farm Plan Community Town Hall No. 2 entitled The Future of Agriculture on Salt Spring Island is scheduled on February 1, 2020 1:00 p.m. to 4:00 p.m. and noted the application to be a delegation at the March 2020 Trust Council on Salt Spring Island will close on February 18, 2020.

12. CHAIR'S REPORT

Chair Luckham reported Trust Council is reviewing how to facilitate electronic meetings as part of the Islands Trust Declaration of a Climate Emergency and commitment to reduce carbon emissions. Chair Luckham is planning to attend the Financial Planning Committee meeting on January 22, 2020 regarding the draft 2020/2021 budget and noted the Islands Trust is seeking public feedback regarding the draft 2020/2021 budget. Chair Luckham reported there is a proposed affordable housing project on Denman Island that has proposed to be sourced by rainwater only. The next Trust Council will be held on March 10 to 12, 2020 at the Harbour House Hotel on Salt Spring Island.

13. CRD DIRECTOR'S REPORT

Capital Regional District (CRD) Electoral Area Director Gary Holman reported the following:

• The CRD has initiated an Alternate Approval Process (AAP) to increase funding for an additional \$10 million to extend the Regional Housing First Program that funds affordable housing projects in the CRD. BC Housing and the Canada Mortgage and Housing

Corporation (CMHC) have committed to contribute \$10 million each for a total of \$30 million. The tax requisition increase must be approved by 11 of the 16 local governments that make up the CRD. The borrowing will cost the average household on Salt Spring Island approximately \$4 per household per year. The AAP petitions are available at the CRD office and the AAP process will be open until February 18, 2020.

- CRD Director Holman is participating in the Climate Action Plan update and the Area Farm Plan update and noted both the draft Climate Action Plan and the draft Area Farm Plan will be available to the public in the Spring.
- The Salt Spring Island Watershed Protection Alliance (SSIWPA) has agreed to a 2020-21 workplan and one of the priority items is a water availability study for Weston Lake. CRD Director Holman reported the applicant of the Vortex project at the old Fulford Inn property has proposed to be included in the Fulford Water Service Area. There will be a review regarding whether the Fulford Water Service Area has sufficient water supply to provide water to properties along the proposed extension.
- CRD Director Holman expressed support for permitting suites in the Fulford Village Area to increase affordable housing.
