# 8.1 Bylaw No. 480 - Riparian Areas Regulation Salt Spring Island

### SS-2014-210

It was **MOVED** and **SECONDED** that the Salt Spring Island Local Trust Committee amend Proposed Bylaw 480 cited as "Salt Spring Island Official Community Plan Bylaw No. 434, 2008, Amendment No. 2, 2014" by:

- Inserting into Schedule 1 an information note that reads "Measures identified in Section 4 of the Riparian Area Regulation (RAR) Assessment Report Form, or other direction provided by the Qualified Environmental Professional (QEP), which occurs between the calculated Streamside Protection Area (SPEA) and the 30 meter Riparian Assessment Area (RAA) should be incorporated into the Development Permit;"
- 2. Amending the map 28 legend shown in schedule 2 as recommended in the Staff Report dated October 28, 2014;
- 3. Replacing E.7.5.1 (e) with "Restoration and enhancement activities by persons undertaking only to restore and enhance the natural features, functions and conditions of riparian areas as approved in a signed and sealed letter from a Qualified Environmental Professional (QEP) submitted to the Islands Trust;"
- 4. Replacing "may be required" in E.7.6.6 with "should be required."

Trustee Grams reported that he attended meetings with the following: the Shared Space Salt Spring Society Annual General Meeting; with constituents regarding various issues; the Chair of the Capital Regional District (CRD) Highland/Fernwood Water Commission; a member of the Industrial Advisory Planning Commission; the Salt Spring Island Watershed Protection Authority (SSIWPA) coordinator; the SSIWPA Public Advisory Committee; a member of the Water Council and the Local Planning Committee and the Advisory Planning Commission. He also attended the following: the SSIWPA Structured Decision Making Workshop; Transition Salt Spring event and a presentation of the CRD Community Economic Development Commission (CEDC) report, "Toward a More Resilient Salt Spring". He expressed appreciation to Chair Malcolmson, Trustee Grove and Director McIntyre.

### 12. CHAIR'S REPORT

Chair Malcolmson reported the following topics from Trust Council: release of a letter to Premier Clark and Minister Stone regarding the impacts of BC Ferries proposed fare increases and service reductions; initiation of a consultation process by Transport Canada regarding Marine Waste Disposal which provides an opportunity to identify particularly sensitive shoreline areas and also commended the Trust Council on participating in the National Energy Board (NEB) process regarding the Liquefied Natural Gas (LNG) Oil Tanker Expansion project. She attended the Howe Sound Community Forum hosted by the Squamish Nation and encouraged Trustees to prioritize relationship building with First Nations. She also reported the Trust Fund acquisition of the McFadden Creek Nature Sanctuary on Salt Spring Island. She expressed appreciation to Trustee Grams, Trustee Grove, Director McIntyre and Islands Trust staff.

### 13. CRD DIRECTOR'S REPORT

Director McIntyre reported that he attended the following meetings: the Capital Regional District (CRD) Budget meetings; Annual General Meetings of the CRD Water Commissions, Liquid Waste Commission and Sewer Commissions; regarding the Recycling Depot; the owners of the Sablefish Hatchery; regarding the Fulford Inn; with Brendan Carr, Island Health Chief Administrative Officer; the Lady Minto Hospital Foundation; the CRD Transportation Select Committee; the CRD Ferry Advisory Committee and the CRD Environmental Services Committee. He attended the following: a presentation of the CRD Community Economic Development Commission (CEDC) report, "Toward a More Resilient Salt Spring"; the Business of the Year Awards presentation hosted by the Chamber of Commerce and the Salt Spring Island Watershed Protection Authority (SSIWPA) Structured Decision Making Workshop.
