#### 6. BUSINESS ARISING FROM THE MINUTES

#### 6.1 Follow-up Action Report

Planner Richardson reviewed the on-going items. He advised that purchase of SFU well testing report is ongoing; MA-TUP-2012.2 (Bennett) is on today's agenda; and that Item 14 – notification to APC regarding referrals: this will be done via email following the LTC resolution.

#### 8. CORRESPONDENCE

The LTC is in receipt of correspondence regarding the proposed MA-TUP-2012.3 (Nordquist). Correspondence received concerning an application and/or project is considered with the application.

#### 9. APPLICATIONS, PERMITS, BYLAWS AND REFERRALS

#### 9.1 MA-TUP-2012.3 (Nordquist)

Planner Richardson outlined the three options for the application:

- a) it goes no further;
- b) proceed as drafted and will be on agenda for September 19;
- c) amend the permit and then proceed to September 19<sup>th</sup> meeting.

Trustee Dodds requested that the application be sent to the Advisory Planning Commission as this is an important decision for the island community.

Robert Kojima outlined that the APC referral could detail parameters for the permit and these could also be circulated to neighbours prior to the September meeting.

Trustee Crumblehulme requested a letter of approval from the appropriate water board be obtained.

Trustee Dodds spoke to removing the advertising restriction.

Chair Luckham stated that to allow unrestricted advertising increases the "commercialization" of the operation and if owner wants to operate a commercial business can apply to rezone.

Trustee Dodds stated that to rezone is a separate issue. There is a current enforcement process for those who are advertising and operating a STVR without a permit.

#### Resolution MA-LTC-35-12.

It was Moved and Seconded that Mayne Island Local Trust Committee refers MA-TUP-2012.3 (Nordquist) to the Mayne Island Advisory Planning Commission, with an amendment to item k) and deletion of item I), for consideration.

#### 9.2 MA-TUP-2012.2 (Bennett)

Gary Richardson reviewed the application information to date. A draft permit has been prepared. Responses have been received from the Fire Chief; comments from VIHA have been incorporated; Ministry of Transportation has made a site visit.

There was discussion regarding specifications of drafted permit and required parameters/structures for the operation.

Applicant spoke to requirement of a sump operation to pump off rain water. Truck could be put under a cover. The infrastructure requirements are felt to be onerous and costly. All agreed that requirements are best practice principles.

Chair Luckham reminded everyone that Islands Trust does not want to be involved in the management of the business – just wants to ensure neighbours and community concerns are addressed and that "best practices" are implemented.

Fred Bennett, applicant, asked if the use as a solid waste transfer site would be added on to the Industrial Use Zone.

Planner Richardson stated this could be the long term plan – either through application or the LTC could amend the zone in the LUB.

Staff will amend draft permit, consult with applicant and application will be on agenda for September meeting.

Note - Trustee Dodds excused herself from the meeting at 2:49 pm, due to a conflict of interest.

#### 9.3 Proposed Mayne Island Bylaw No. 157 – for consideration of adoption

Bylaw No. 157 was approved by the Executive Committee of the Islands Trust on July 3, 2012.

#### 10. LOCAL TRUST COMMITTEE PROJECTS

#### 10.1 Secondary Suites - Report

Planner Richardson spoke to the report of the Mayne Island Housing Options Task Force. Currently secondary suites are not permitted on the island.

Trustee Dodds reported that 70 to 75% of properties are already developed and few existent houses could be retrofitted for a secondary suite. It would be worthwhile to send a letter to all property owners informing them that the LTC is looking at permitting secondary suites and to get information back before debating the issue.

Trustee Crumblehulme stated that permission should only be given where the specific water board approves and that secondary suite does not necessarily mean a basement unit – could be an addition.

#### Resolution MA-LTC-38-12

It was Moved and Seconded that the Mayne Island Local Trust Committee request staff to send a letter to all property owners and water boards outlining a proposal to permit secondary suites to be included in a dwelling.

Chair Luckham spoke to working at getting bylaws processed and preparing for next Trust Council meeting on Bowen Island. The National Marine Conservation Area is continuing to develop. The Kinder Morgan Pipeline is of concern to many and for Islands Trust as it has a mandate to protect marine environment.

#### 11.8 Trustee Report

Trustee Crumblehulme spoke to the Economic Development Commission which has three members from Mayne Island. The CRD is looking to support endeavors through regulations/licensing processes. All Islands are feeling the economic stress. There is a proposal to create a hiking, cycling and water trail to connect all the islands through to Vancouver Island – "Explore the Gulf Islands". This would be viewed as an extension of the TransCanada Trail and would involve all levels of government. Trustee Crumblehulme will chair the Mayne Island Advisory Team for this project and will report to the CRD regarding the activities of the group. Trustee Crumblehulme questioned if this activity posed any conflict of interest and Chair Luckham felt not at this time.

Regarding the high speed internet, Trustee Crumblehulme has had contact with Network BC, which supports high speed connections in remote areas and Mayne Island is eligible to apply for a grant in October. He is looking for assistance to draft this application.

#### 12.2 Mayne Island Name

Trustee Dodds will be contacting the BC Geographical Names Office regarding having the island's name officially changed back to Mayne Island. "Island" was dropped in 1939 and many residents have been voicing concerns to Canada Post (which implemented the deletion of Island in November of 2011) however Canada Post cannot do anything without a directive from the Names Office.

Trustee Dodds asked for a resolution to pursue this on behalf of the LTC. After a brief discussion it was agreed that Trustee Dodds would draft a letter requesting reinstating "Island", circulate it to LTC members and it could be approved through a Resolution-without-meeting.

David Maude (resident) expressed appreciation for efforts regarding changing name back to Mayne Island.
