#### 1. CALL TO ORDER

Chair Rogers called the meeting to order at 1:05 p.m. Chair Rogers acknowledged that the meeting was being held in traditional territory of the Coast Salish First Nations.

Chris Roehrig raised concerns regarding Draft Bylaw 180 specifically 2.13 and 2.16 which address docks and identified concerns related to removing the statement "for all residents".

Chair Rogers stated Draft Bylaw will go to a Public Hearing which allows community input.

Planner Chadwick identified that purpose of removing "for area residents" opens up usage to more than just residents.

#### 7.1 Follow-up Action List Dated June 2020

Planner Chadwick – prepared to answer questions.

Trustee Maude raised a number of issues with Ministry of Transportation and Infrastructure (MoTI); no mowing along sides of roads, asphalt, signage to highlight a few.

Meeting organized with CRD Building Inspections went very well and would like to see meeting with MoTI finalized.

Planner Chadwick suggested Trustees submit specific issues that could then be forwarded to MoTI.

# 8. DELEGATIONS

# 8.1 Mayne Island Housing Society

Deborah Goldman, President Mayne Island Housing Society, and Andrew Smith, Director, presented the history of the Mayne Island Housing Society and goal of establishing affordable housing on the island:

- Property is on Village Bay Road, 3 acres, that would be an ideal location. Plan is to subdivide acreage and donate the 3 acres as a Community Amenity to the Society;
- The project fits with Official Community Plan (OCP) and would consist of 10 housing units of 1 to 3 bedrooms with a mix of affordable housing and market rate rentals;

- Site has been tested for water and there is sufficient for purpose and there would be a system for collection of rain water;
- Entire development would be designed for minimal environmental impact;
- Clarified that housing is not subsidized Society not applying for government housing monies.

Chair Rogers thanked the delegation and reported that he is looking forward to working through project.

# 9.1 Response to Capital Regional District re St. John Point Regional Park

Chair Rogers stated a letter was sent to CRD outlining concerns regarding parking lot.

CRD response dated June 23, 2020 noted limited roadside allowance for parking and that a lot for 20 vehicles is felt appropriate. CRD prepared to work/meet with IT staff and will present outcomes to LTC.

Discussion was held and the following points were made:

- 1. 10 parking spaces sufficient for rural community
- 2. Encourage parking close to or adjacent to roadway not within park

#### 11. LOCAL TRUST COMMITTEE PROJECTS

#### 11.1 Land Use Bylaw Technical Review

Planner Chadwick summarized the proposed amendments to the Land Use Bylaw (LUB). Key areas of focus included: the definition of a Passive Park, definition of Community Wharf and zoning for the Mayne Island Resort dock which has been existing under a Temporary Use Permit (TUP).

#### Points of discussion:

- In the definition of community wharf, "for area residents" be put before "and emergency services";
- Resort dock has been in place for over 50 years: TUP due for renewal no complaints for past three years;
- Concerns raised that proposed wording for Passive Park is allowing for more than what a passive park is intended for (passive park should be for preservation purposes primarily);
- Information notes can be added for clarification: wording more appropriate for OCP:
- "and no other uses" to be added at the end of the definition of "Park, passive recreation";
- Section 2.6 be amended to read "Passive recreation park, each park limited to hiking and walking trails and signs not exceeding 1 square metre each"; and
- Definition of recreation vehicles is currently quite expansive: to narrow definition would make Bylaw Enforcement easier.
